Fund objective and policy

The Fund aims to achieve high returns by investing in a balanced portfolio of convertible bonds. The Fund is actively managed. It is not constrained by its comparator benchmark, the FTSE Global Focus Customised TR Index, and has significant freedom to invest in a portfolio that is materially different to the benchmark's composition. The Fund seeks to achieve its objective by investing in bonds issued by corporations located in Europe, the US, Japan and Asia. The Fund normally holds at least 51% of its assets in convertibles the Manager considers investment grade, subject to the convertible bond market providing sufficient 'balanced' investment grade opportunities to run a well-diversified portfolio. A balanced convertible is one not trading too far above its bond redemption value and/or not trading at too high a conversion premium.

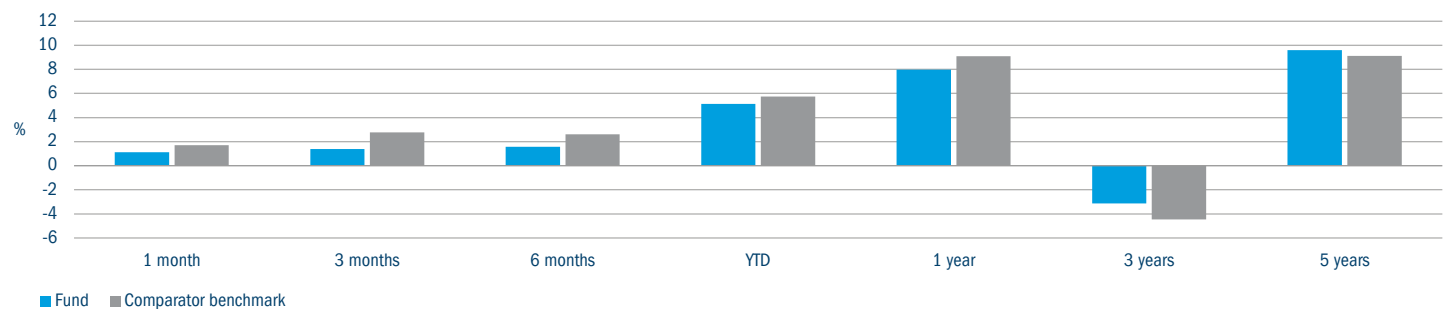
