Fund Profile

- Thematic fund invested in equities issued by companies around the world whose innovation helps to protect and improve the quality of life.
- The investment theme was implemented in three key areas: innovation in the healthcare sector/natural resources management/digitisation for individuals and companies.
- Funds with global geographical exposure, more focused on areas with strong innovation momentum, with no restrictions in terms of company capitalisation.
- Conviction fund, concentrated on a limited number of stocks with higher sales and earnings growth potential than the market.
- The sub-fund is therefore intended for investors seeking long-term capital gains in exchange for the volatility associated with this type of investment.
- The sub-fund may invest up to 10% of its net assets in units of UCITS and other UCIs. The reference currency of the sub-fund is the US dollar (USD).

Risks

- Market risk: risk of loss that may result from fluctuations in the prices of financial instruments.
- Liquidity risk: liquidity problems in the financial markets that may affect the purchase and sale of fund positions.

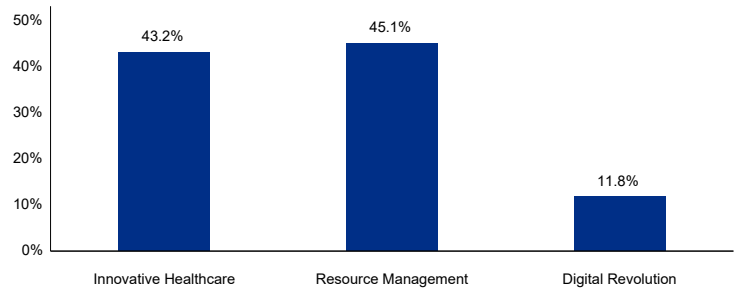
