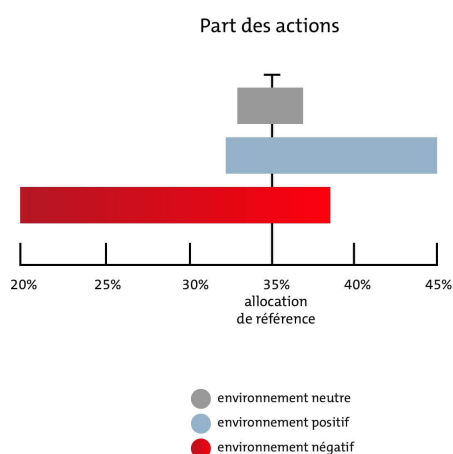

Risk profile



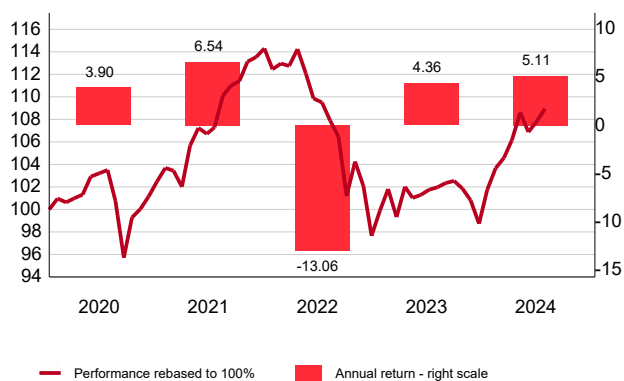

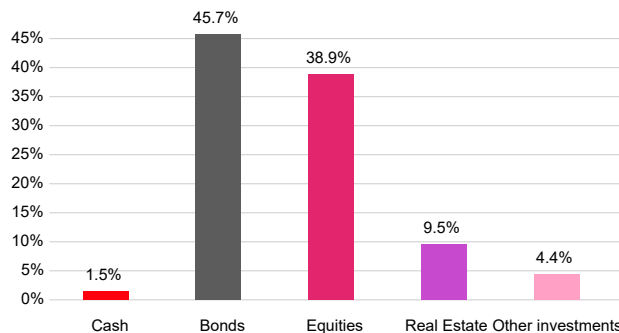

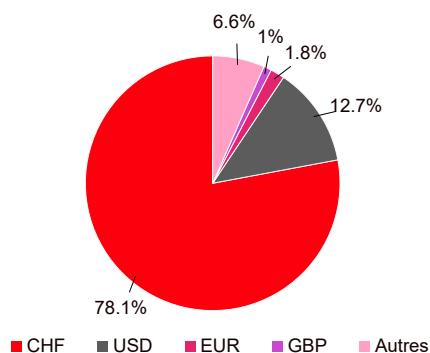
