Risk profile

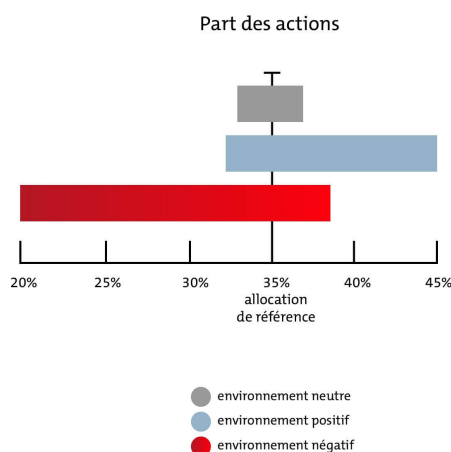

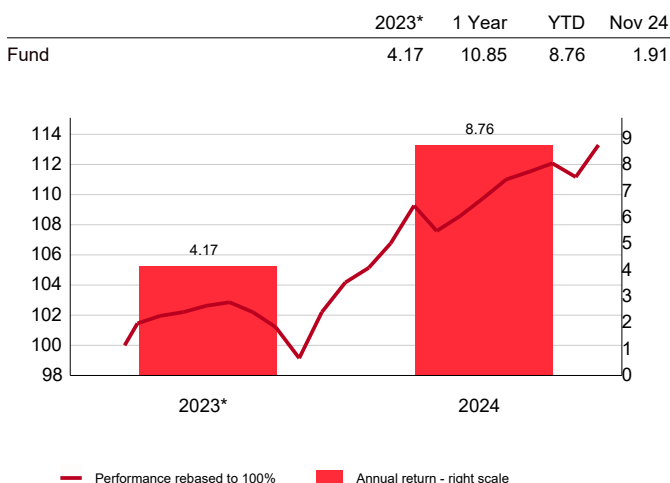

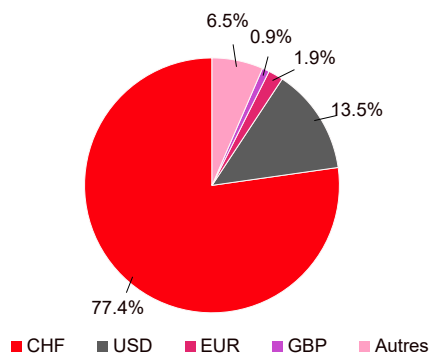
