Risk profile

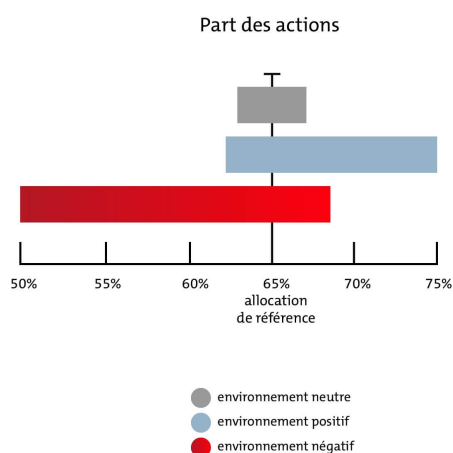

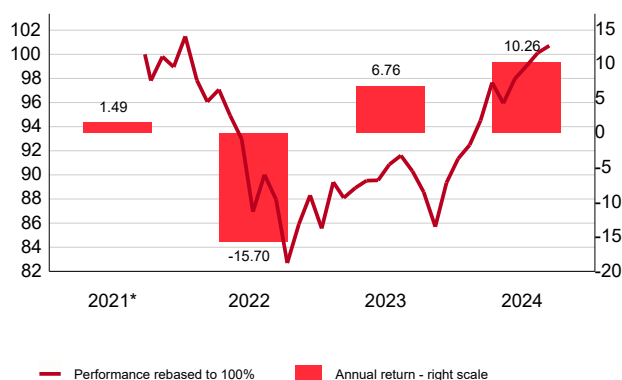

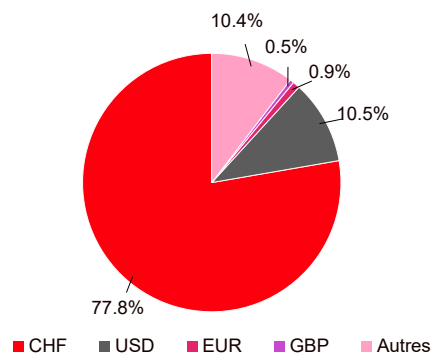
