Risk profile

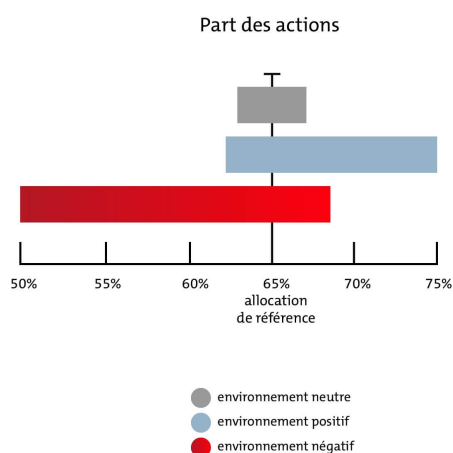

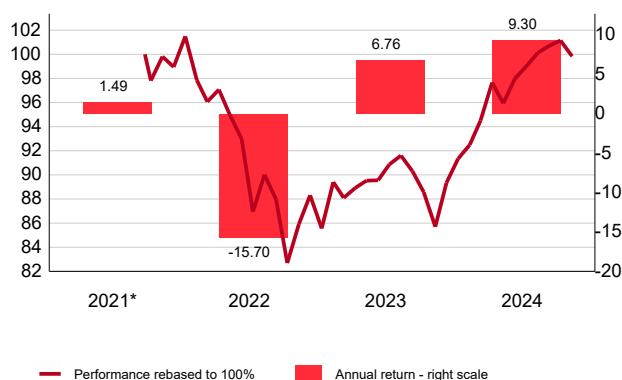

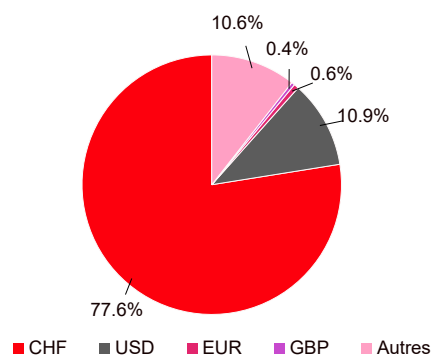
