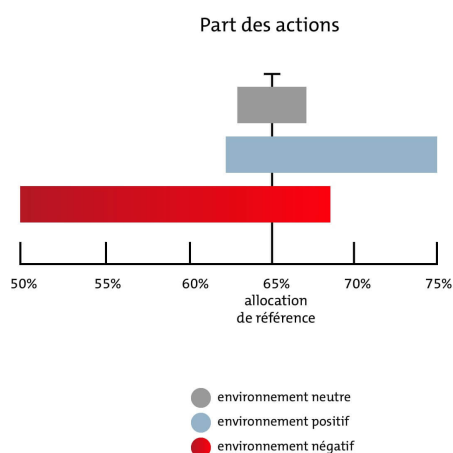

Risk profile



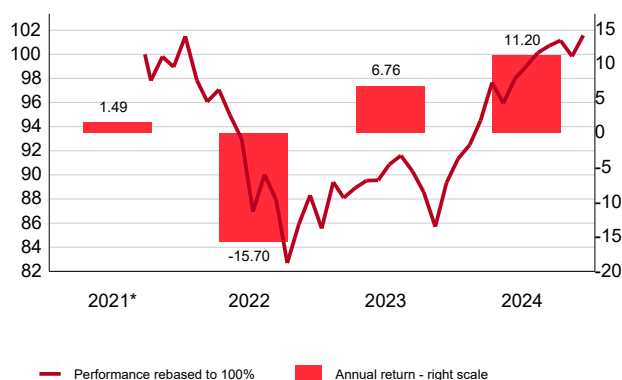

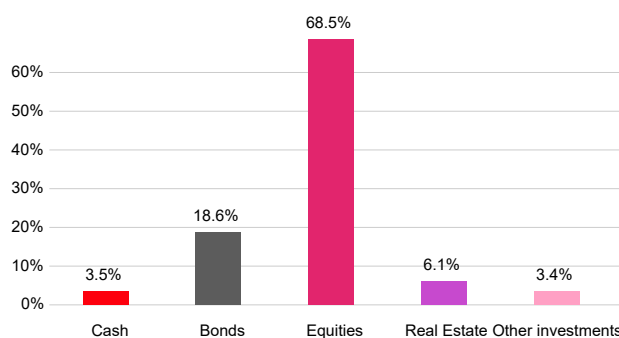

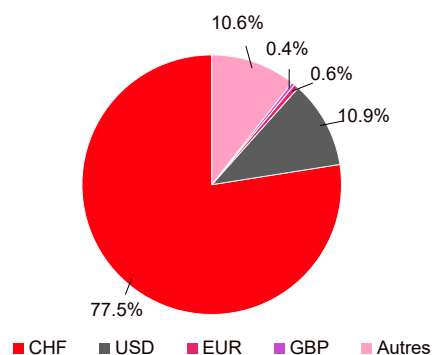
