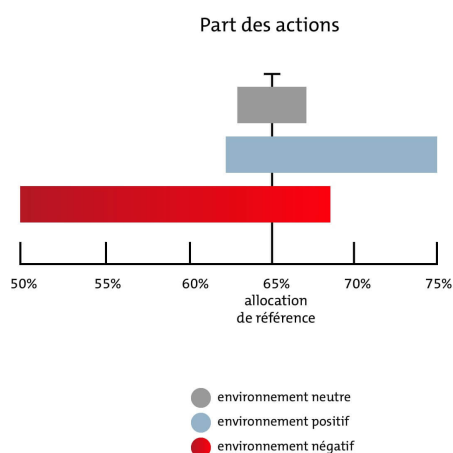

### Risk profile



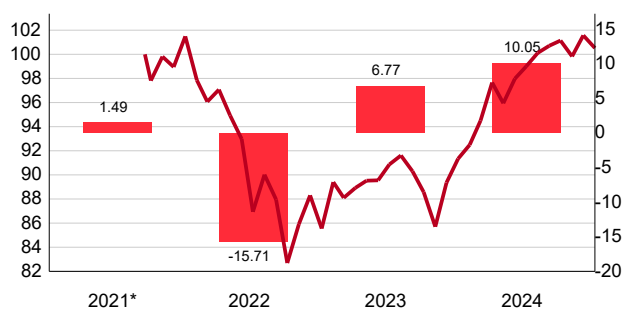

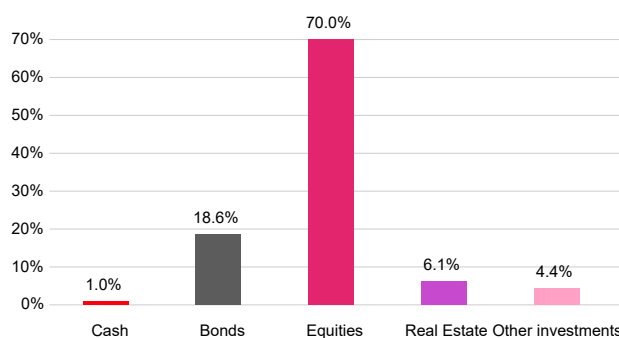

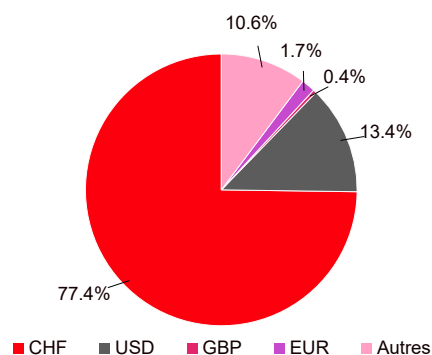
