Risk profile

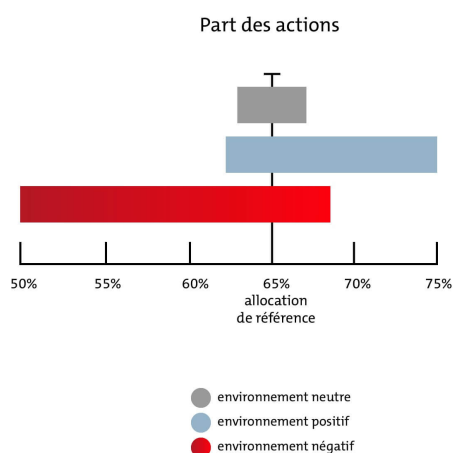

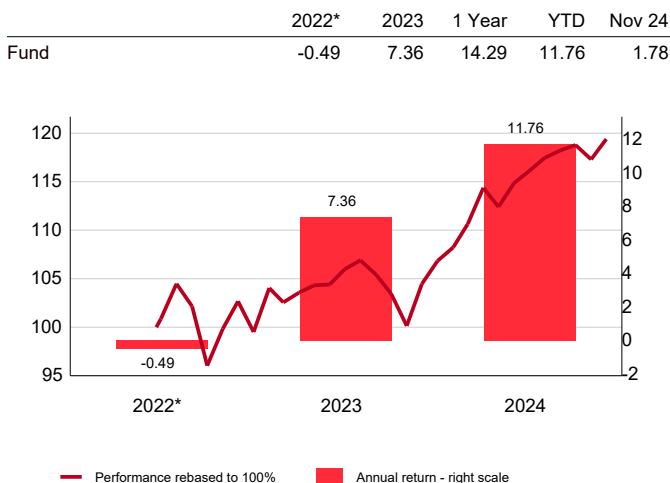

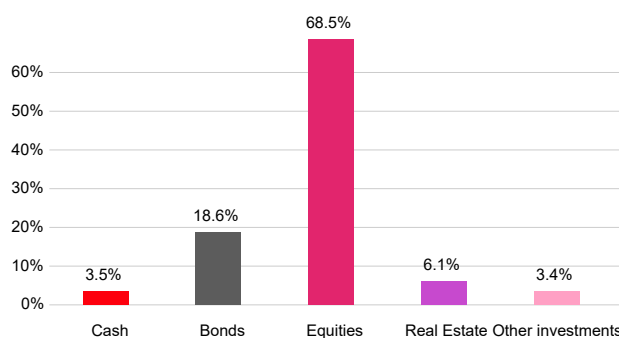

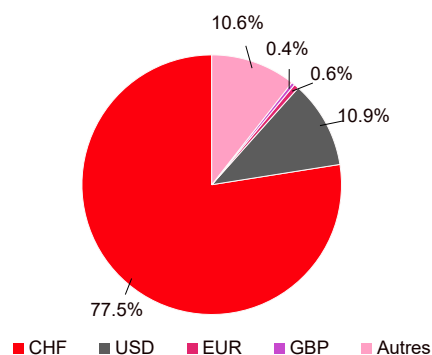
