# **INVESTMENT POLICY**



The sub-fund is also authorised to invest, directly or indirectly, a maximum of 50% of its assets in money market instruments. It may also invest up to 15% of its assets in commodities, via units of collective investment schemes and structured products, and in real estate, via units of collective investment schemes and real estate companies, up to a maximum of 30% of its assets.



## **ALLOCATION ASSET CLASSES IN%**





## **POTENTIAL RISKS**
