## Investment policy

The "Swiss Rock (Lux) Emerging Markets Equities ESG" fund invests in emerging market equities. The fund portfolio is broadly diversified and practically fully invested. The individual countries are weighted according to their stock market capitalisation. The active stock selection takes into account ESG criteria as well as ESG trends and is based on country- and region-specific factor models developed by Swiss Rock, which take into account the particular characteristics of the respective markets. The fund is particularly interesting for investors seeking broadly diversified "exposure" to global, capitalisation-weighted emerging markets.
