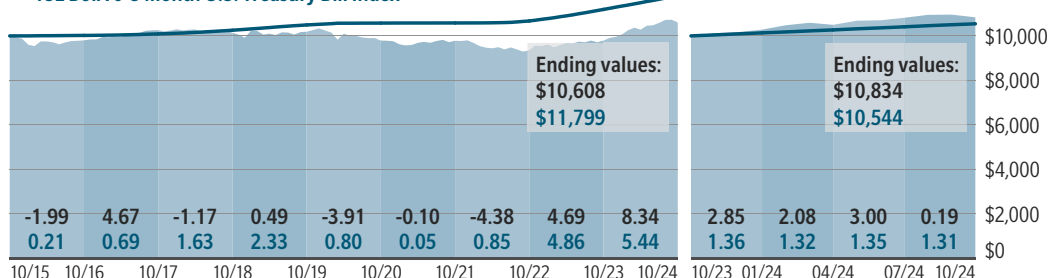

### Important Data Methodologies
