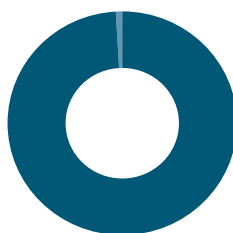
The fund's investment objective is to seek capital appreciation, measured in U.S. dollars.

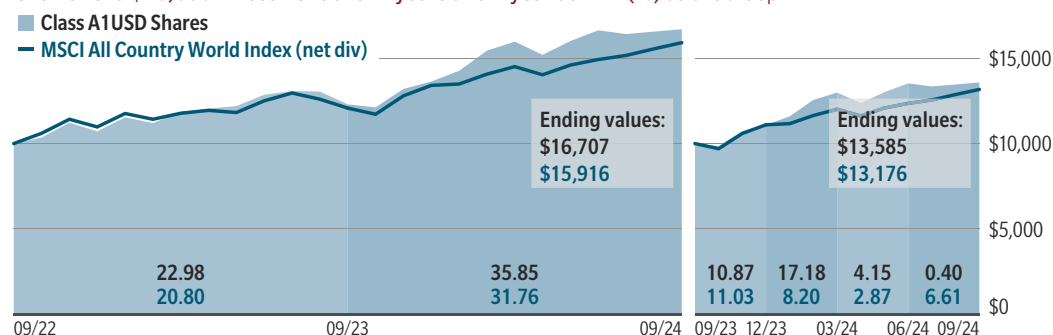
