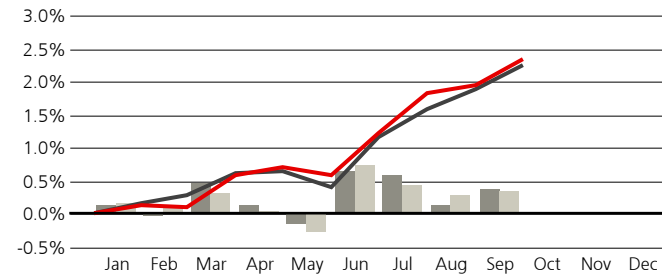
Investment Policy

Performance overview - monthly & cumulative

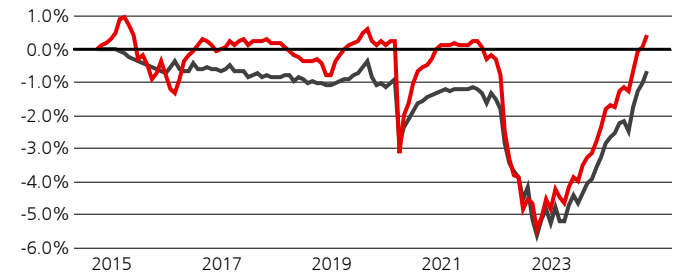

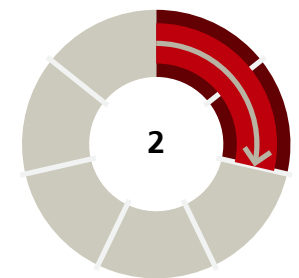

Performance review

Falling interest rates and a narrower swap spread have helped CHF-denominated corporate bonds to perform well during the quarter. Absolute and relative performance were positive with the biggest contribution to absolute performance coming from the financial sector, followed by industrials. An interest rate swap that we set up in December 2023 based on our view that interest rates fell too quickly was unwound in September at a cost of -5bp. We no longer think that interest rates will change course meaningfully after the last SNB meeting. Hence, relative performance was negatively impacted by the shorter duration and underweight in bonds with longer tenors. However, this was more than offset by the positive contribution coming from sector allocation and security selection.

Market Review

The interest rate cycle has firmly turned in Q3 as the US Fed joined the group of central banks cutting rates this year. Even as the US economy has remained on a solid economic footing, inflation has dropped significantly from the peak reached last year. This allows central bankers to ease monetary policy and support businesses and the government with lower interest rates. Also noteworthy is the significant stimulus under way in China. Policy makers have decided that growth needs to return to the 5% target and are willing to invest in key infrastructure and the housing market to revive the slowing economy. Markets have reacted positively even as the chances of a larger war in the Middle East have increased. Israel is attacking terrorist groups now in the Gaza Strip as well as in Lebanon and risks escalating tensions with Iran and its allies across the region. The SNB announced a third consecutive rate cut this year and remained dovish in its outlook. The yield curve has now normalised between 3y and 20y.

Asset breakdown by ESG controversy flag











Asset breakdown by ESG rating



Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by IBOXX sector and are security weighted.
