





Performance review

The fund's current yield to maturity is 4.77 with a modified duration of 1.85 years and an average credit rating of BBB+. The fund delivered a positive absolute performance in August driven by falling interest rates and credit spreads. Over the month, the duration exposure has been kept neutral, while there was no significant change to the credit risk sensitivity of the fund.

Market Review

Global fixed income markets had a positive month in August on the back of macro data and confirmation that Fed officials will likely cut rates at their next meeting in September. Inflation in the US continued to decline at a rate that was in line with market expectations. Credit spreads widened initially amid a global sell-off triggered by weaker-than-expected jobs data, but quickly recovered and traded tighter as subsequent data such as retail sales, GDP and jobless claims highlighted the resiliency of the US economy. Yields on 5-year and 10-year US government bonds fell by 21 and 13 basis points, respectively. In contrast, rates markets in Europe were relatively muted, with yields on the German 10-year Bunds unchanged, while those on the UK 10-year Gilts were 4 basis points higher. On the credit side, US credit outperformed its European counterparts mostly due to the movement in rates. From a credit-spread perspective, high yield sovereigns leading the charge.
