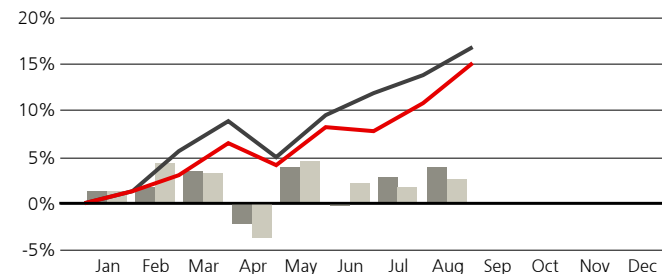
## Investment Policy

## Performance overview - monthly & cumulative

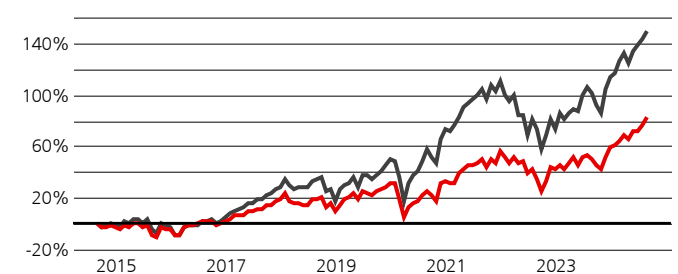

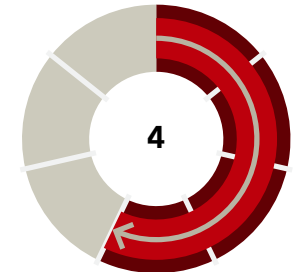

## Performance commentary

In July, the fund outperformed the MSCI World NR in USD.

The dividend yield style contributed positively overall to relative performance, as the 40% of the benchmark with the highest yielding stocks outperformed. At the sector level, the best-performing sectors included real estate, while healthcare and consumer staples. The fund was underweight in real estate, but overweight in health care and consumer staples. The real estate sector benefited from lower interest rates, as measured by the US 10-year Treasury yield, and the relatively defensive (lower beta) sectors health care and consumer staples outperformed on the back of recession fears at the beginning of August, in our opinion. On the other hand, the worst-performing sectors were energy, consumer discretionary and information technology (IT). The fund was underweight in all three of these sectors.

At the stock level, top contributors included Amazon, CME Group and Astra Zeneca. On the detractor side, Emerson Electric, Netapp and Eli Lilly contributed negatively this month.

## Market comments

Equity markets ended August on a high note, rebounding from a rapid sell-off at the start of the month to finish at a record high. The unwinding of yen carry trades prompted some investors to sell risk assets, leading to a roughly 6% decline in the S&P 500 during the first days of trading in the month. Sentiment was also dented by weak US jobs data, which stoked fears that the Federal Reserve had waited too long to ease monetary policy and hence a recession was imminent – or had already started.

The mood in the markets recovered, leaving both global and US stocks higher for the month. The MSCI All Country World Index ended 1.8% higher for a year-to-end-August return of 16.8%, leaving it at a new record high. The S&P 500, which was closed on 2 September for the Labour Day holiday, returned 2.4% in August and has gained 19.5% so far in 2024. It stood just 0.3% from an all-time high reached in mid-July.

The turnaround was due to several main shifts. First, the drag from technical factors – such as the yen carry trade and overextended investor positions in tech stocks – faded. Second, stronger US economic data suggested that concerns about a recession were premature. Meanwhile, the Fed gave its clearest signal to date that rate cuts are on the way, with Chair Jerome Powell saying the “time has come” for easing.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO <sub>2</sub> -equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
