


#### **Investment Policy**



#### **Performance commentary**

In November, the UBS (Lux) Global Quality Dividend Equity Fund underperformed the MSCI World NR in USD.

The dividend yield style contributed negatively to performance, as the 40% of the benchmark with the highest yielding stocks underperformed the overall benchmark, while the 20% with the lowest yielding stocks were the best-performing dividend guintile.

The most notable outperforming sectors include consumer discretionary, financials and information technology. The consumer discretionary sector rallied despite President-elect Donald Trump's plan to increase tariffs globally, due to the outperformance of the automobiles and components stocks. In our view, the financial sector was helped by how the market perceives the incoming President's potential lighter-touch capital regulation for banks. The information technology sector benefited from declining interest rates (as measured by the US 10-year Treasury yield) towards the end of the month. The most notable underperforming sectors included materials, healthcare and utilities. This was in our view, to some extent, also driven by the market's view of the possible impact of policies that the Trump administration is expected to favour.

From a stock perspective, positive relative contributors included Emerson Electric, IBM and JPMorgan Chase. Emerson reported earnings on 4 November. IBM and JPMorgan Chase are in the two best-performing sectors for this month, information technology and financials, respectively. On the downside, negative relative stock contributors included Tesla, Abbvie and Givaudan. We did not own a position in Tesla, which outperformed and as such contributed negatively to relative performance. Abbvie posted phase II results for Emraclidine which did not meet their primary endpoint (source: Abbvie). Givaudan continued its negative momentum from last month, although last month it posted decent earnings including double-digit organic sales growth which exceeded expectations (source: UBS).

#### **Market comments**

Global equities increased in November as measured by the MSCI World TR Index in USD.

Unsurprisingly, Donald Trump's decisive victory in the US presidential election in combination with a red sweep was the dominant market driver in November. The event has passed, but the macro and policy implications – details of which remain uncertain and will only be unveiled over time – will set the tone for the next few years. As a red sweep is expected to lead to fiscal expansion, US bonds lost in value. US equities – benefiting from lower taxes and lighter regulation, on top of the solid economic backdrop already in place – outperformed other regional markets, which face increased tariff risk. These dynamics also led to a stronger USD across the board. The initial market reaction has been largely in line with expectations: The S&P 500 topped 6,000 for the first time, and outperformed other main regions. The US dollar strengthened broadly to a fresh 2-year high and 10-year Treasury yields spiked above 4.4%, but both reversed course in the final days of the month.
