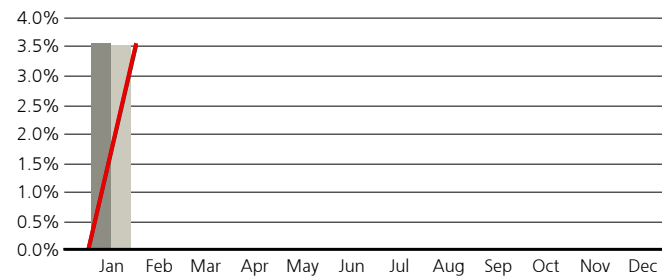

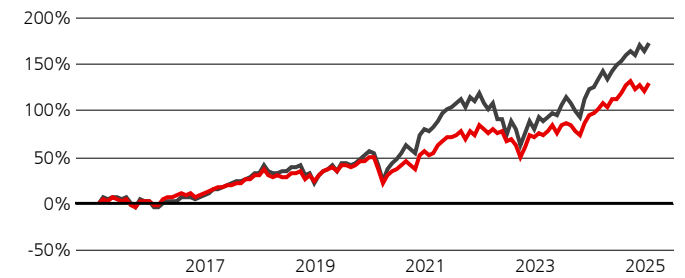

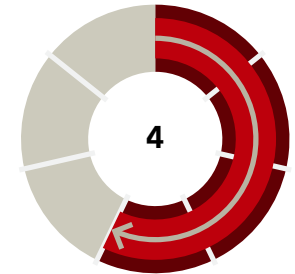

**Performance commentary**

In January, the UBS (Lux) Global Quality Dividend Equity Fund performed roughly in line with the MSCI World NR in USD.

The dividend yield style contributed positively to performance, as the 40% of the benchmark with the highest-yielding stocks outperformed the overall benchmark.

The most notable outperforming sectors included communication services, financials and healthcare. The communication services sector outperformed due to the strong performance of the media and entertainment stocks. The financials sector did well also due to the strong performance of the bank stocks. The healthcare sector was the best-performing defensive sector.

The most notable underperforming sectors include real estate, consumer staples and information technology. The real estate sector may have underperformed as the US Federal Reserve (Fed) is expected to cut rates in 2025 by less than investors had previously assumed (source: UBS CIO GWM, 20.12.2024). The consumer staples sector underperformed as consumer staples distribution and retail stocks lagged. The information technology sector was the worst-performing sector in January, as Chinese start-up DeepSeek developed powerful Artificial Intelligence (AI) models at a lower cost than its leading US peers. From a stock perspective, positive relative contributors included Nvidia, IBM and Apple. We did not hold a position in Nvidia or Apple, both of which underperformed and as such contributed positively to relative performance. IBM outperformed on the back of posting earnings results on 30 January, with its guidance for free cash flow in 2025 standing out positively (source: Bloomberg). On the downside, negative relative contributors included Broadcom, Meta Platforms and Dell Technologies. We did not own Meta Platforms and it outperformed, leading to a negative relative contribution for the fund. Broadcom and Dell Technologies underperformed, alongside many stocks in the IT sector. The IT sector reacted negatively to the emergence of DeepSeek's latest open-source AI model.

**Market comments**

Global and US stocks gained ground in January, despite headwinds from a more hawkish Federal Reserve, the launch of DeepSeek's low-cost AI model and aggressive tariff policies from the new Trump administration. The MSCI All Country World Index returned 3.3% over the month, with the S&P 500 advancing 2.8%. With President Donald Trump returning to office earlier this month, he announced plans to impose 25% tariffs on imports from Canada and Mexico, citing fentanyl flows and large trade deficits, while also indicating that China would face additional tariffs. Investor apprehension also grew following the launch of a lower-cost AI model by Chinese firm

DeepSeek, which raised concerns over demand for high-end chips and the potential for intensified competition for top US tech firms. This was followed by the Federal Reserve's first policy meeting of the year, where policymakers paused rate cuts for the first time since the start of its easing cycle and indicated they were in no rush to cut further. Despite these headwinds, market sentiment remained resilient, supported by a combination of benign inflation and solid growth in the US. The Consumer Price Index (CPI) showed monthly core inflation slowing to 0.2% in December, down from 0.3% in the prior month, while job growth exceeded expectations. For the fourth quarter, the US economy grew by 2.3%, underpinned by the fastest consumer spending growth in two years. Markets were also supported by confidence that the Fed's hiatus from easing didn't mean the end of the cutting cycle.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
