Investment Policy

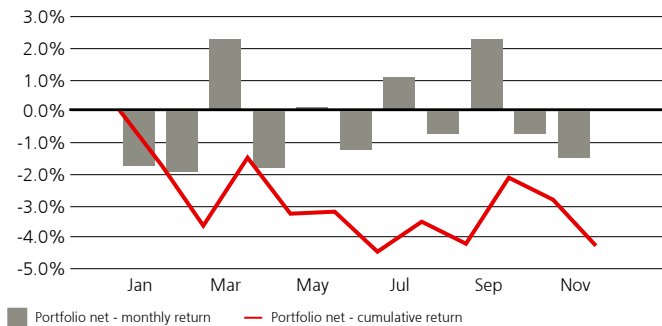
The UBS (Lux) European Small and Mid Cap Equity Long Short Fund aims to generate absolute positive returns by exploiting the inefficiencies of the small and mid-cap markets in Europe with a focus on German speaking countries. The portfolio managers buy the equities they think will perform best, while at the same time selling stocks in companies that, in their views, will underperform the market. The objective is to create a portfolio that has lower volatility, less correlation with the equity markets and a better risk-adjusted performance than a long-only fund.

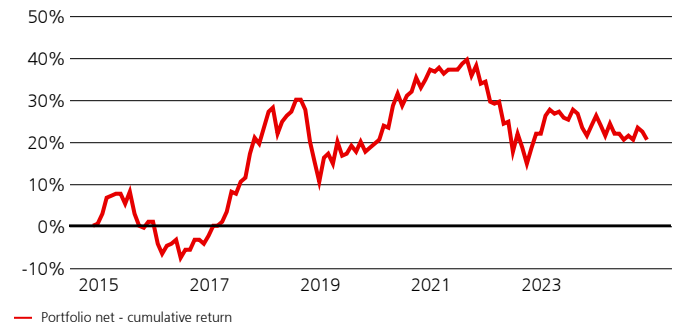
Performance overview - monthly & cumulative

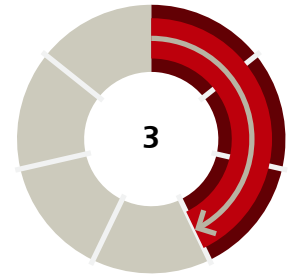

Market commentary

November was driven by the peak earnings reporting season, which continued to paint a mixed picture. The European consumer remains selective in spending overall, but has shown signs of improvement in certain categories (such as e-commerce and travel) and is receptive to discounts. From a sector perspective, financials and leisure have performed well while early cyclical sectors chemicals and autos still suffered. Macroeconomically, PMIs in Europe are still trading at subdued levels. German economic activity remains weak, with the unemployment rate at 6.1%. Inflationary pressures eased in the European economic area, remaining somewhat stable at 2.2% in November. The outcome of the US presidential vote and ongoing geopolitical tensions in the Middle East boosted stock market volatility, with highly US-exposed European companies performing well. In a volatile month, the MSCI Small Cap Europe Index ended November up 1.23%, outperforming large cap indices. The MDAX index was -0.02% in November.

The fund was down -1.37% (retail B share class) mainly because of two single-stock contributions, with CTS Eventim and Hugo Boss being responsible for most of the negative contribution.

Within the long exposure, Eckert & Ziegler and Auto1 were the best-performing positions. Eckert & Ziegler, a provider of low-level radioactive isotopes for medical purposes, raised its FY24 sales and EBIT outlook due to a better start to Q4 across its industrial products and medical division. Eckert & Ziegler furthermore received approval for its proprietary non-carried added chloride solution from the European Commission. This approval means that its proprietary Lutetium-177 radioisotope (branded as Theralugand) can also be used in routine clinical applications across Europe, not just in clinical trials. We built up a new position in Auto1, a company that provides a digital platform for selling and buying cars. Auto1 reported good Q3 numbers and raised its FY24 guidance too, implying significant upwards revisions to current estimates. CTS Eventim and Hugo Boss were the worst-performing long contributors. CTS Eventim saw profit-taking after releasing Q3 results that did not match analyst expectations. Analysts had not adequately captured the seasonality of the recently acquired business and recent M&A activity. Hugo Boss's CEO was accused of potential insider trading allegations, which weighted on the stock's performance.

In the short book, our strongest performers were train manufacturer Stadler Rail and watchmaker Swatch Group. Stadler Rail missed margin expectations in its Q3 reporting and suffered from partial flooding of its Spain-based plant. Swatch Group continued to suffer from weak Swiss watch export numbers, particularly in lower-priced watches (where Swatch is heavily exposed) and in China. Our worst-performing short contributors were steel producer Salzgitter and airline group IAG. Salzgitter is rumoured to be potentially taken over by its major shareholder GP, Günter Papenburg. IAG shares continued to benefit from higher earnings estimates and lower oil prices. We covered our short positions within the month in Salzgitter due to the takeover risk and in IAG due to the improved fundamentals.

While monetary policy and easing continue to be important factors, the short-term focus will be on the political implementation of the US election results (both for the US itself and the broader global economic community, with a special focus on potential tariffs across different sectors). A key focus will be on China, which is still lagging on economic terms, and its trading relationship with the United States. As inflation figures start to level off and US economic figures remain stable, the odds for a soft landing and subsequent pick-up of economic growth expectations thanks to lower interest rates has increased. In such an environment, European small and mid caps are expected to perform well due to their sensitivity to the economic cycle. We see an improvement in European consumer sentiment and lower interest rates as upside scenarios. This also explains our net exposure being slightly higher than the long-term average at the end of the month.
