Investment Policy

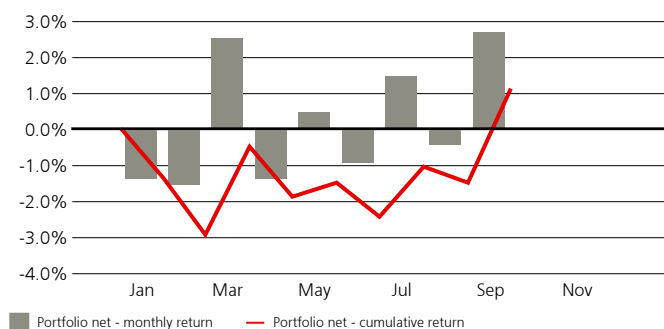
The UBS (Lux) European Small and Mid Cap Equity Long Short Fund aims to generate absolute positive returns by exploiting the inefficiencies of the small and mid-cap markets in Europe with a focus on German speaking countries. The portfolio managers buy the equities they think will perform best, while at the same time selling stocks in companies that, in their views, will underperform the market. The objective is to create a portfolio that has lower volatility, less correlation with the equity markets and a better risk-adjusted performance than a long-only fund.

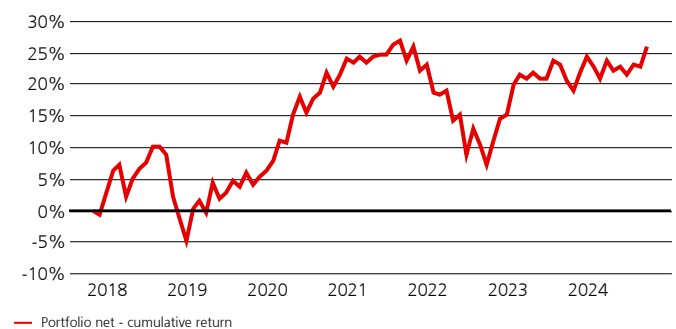
Performance overview - monthly & cumulative

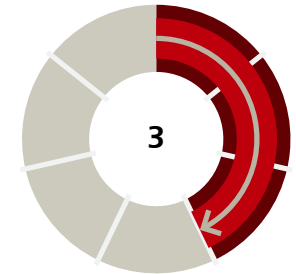

Market commentary

The month of September was characterised by two important events. The first one was the Fed's announcement of an outsized interest rate cut of 0.50%, signalling that the club of major Western central banks including the Fed, the ECB, the Bank of England and the Swiss National Bank have entered an easing cycle which will shape a much looser monetary policy environment than what we had seen in the last couple of years. The second one was a huge stimulus programme announced by the Chinese authorities that includes billions of dollars from the central bank to support the stock market, policy rate cuts, measures to boost bank liquidity and efforts to stabilise China's prolonged property crisis, including a 50-basis-point interest rate cut for mortgage holders. On top of these emergency measures, the government has also cleared the way to intensify fiscal spending to support growth. European small and mid caps reacted positively, outperformed its larger cap peers and recovered lost ground at the of the month after the Chinese announcements. Especially stocks with an outsized Chinese exposure performed well. The MSCI Small Cap Europe Index was up by 0.46%.

The fund was up by 2.39% mainly due to stock picking and a net long position that was slightly higher than the long-term average. In our long book, event ticketing broker CTS Eventim and specialist lubricant manufacturer Fuchs Petrolub were our best contributors. CTS continues to perform well as consumers' willingness to spend time and money for leisure events of all kinds continues unabated. Fuchs Petrolub performed strongly into the end of the month as the Chinese stimulus programme provided relief for cyclical stocks, especially for smaller cap specialists like Fuchs, which has a diversified industrial footprint and good exposure to European and Asian end markets. Medical glass vials producer Gerresheimer and semiconductor manufacturer STMicro were our worst long contributors. Gerresheimer issued a profit warning mainly due to still weak trends observed in its glass packaging division, which still suffers from destocking trends. STMicro was down due to a profit warning related to weak demand for chips related to the automotive and industrial sector. In our short book, our best contributors were information technology provider Kainos and auto OEM Stellantis. Both companies issued a profit warning. Kainos warned that revenues are expected to fall short of expectations with mounting competitive tensions around the services business. The Fiat and Peugeot maker surprised markets with a heavily downbeat update with regard to weak end-market demand, heavy margin contraction and negative free cash flow production only 6 months after the stock staged an all-time high, helped by pricing power that proved to be extremely short-lived. Our worst short contributors were aircraft operator IAG and home appliance producer Group SEB. We are short on IAG mainly for its structurally extremely capital-intensive business with extreme high pricing competition that virtually impedes those companies from producing sustained earnings over the cycle. But good travel demand and current pricing trends have supported the stock recently. On Group SEB, the stock was up thanks to its outsized exposure to the Chinese consumer, which helped the stock to rebound in the wake of the recent Chinese macro policy announcements.

The policy environment has changed dramatically in the last couple of weeks with monetary policy easing around the world, coupled with still important government spending programmes that have been complemented by the Chinese actions recently. As inflation figures start to level off in a digestible range of 2-3%, the odds of a soft landing and subsequent pick-up in economic growth expectations thanks to lower interest rates has increased. Volatility risks around the US election aside, a potential economic recovery in China could help to further sustain global growth expectations. In such an environment, European small and mid caps are expected to fare well due to their sensitivity to global growth in general and to the improving sentiment around the Chinese economy in particular. This also explains our net exposure being slightly higher than the long-term average at the end of the month.
