
Investment Policy





Performance commentary

The UBS (Lux) Security Equity Fund outperformed compared to the MSCI World ESG Leaders Index in the third quarter. Referring to our sub-themes, the strongest contributor was crime prevention, followed by environmental security. On the other hand, IT security was the main laggard. On a company level, the main positive contributor was Fair Isaac (crime prevention), while on the other hand, the main detractor was Dexcom (health prevention), driven by a guidance reduction and a reorganisation of their sales force.

Market comments

Global equity markets advanced in the third quarter, mainly driven by the following factors. 1) Slowing US labour market report: In August it showed that the US generated a net 142,000 jobs, below the consensus forecast of 162,000, while downward revisions subtracted 86,000 jobs from the prior two months. 2) In the eurozone, inflation fell to 2.2%, while in the US inflation fell to 2.5%, whereas in the UK, inflation stayed at 2.2%. 3) The European Central Bank cut interest rates by 25 basis points (bp) to 3.5%, its second rate cut of the year, following indications that inflation is retreating to the 2% target and growth looks set to remain subdued. The US Fed started its rate cutting cycle with a 50bp reduction and the Bank of England kept rates unchanged. 4) In China, the central bank's monetary policy has become more accommodative, support for the property market focused on existing homes, and equity markets also got some support from new monetary tools. (Bloomberg) In addition, China's top leaders vowed to set up "necessary fiscal spending" to meet the country's economic target and to support the economy. (Reuters, 26.09.2024)

We did not do any significant transactions. As usual, we did some rebalancing.
