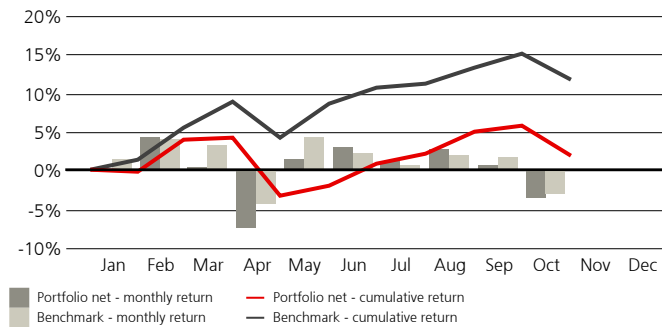
## Investment Policy

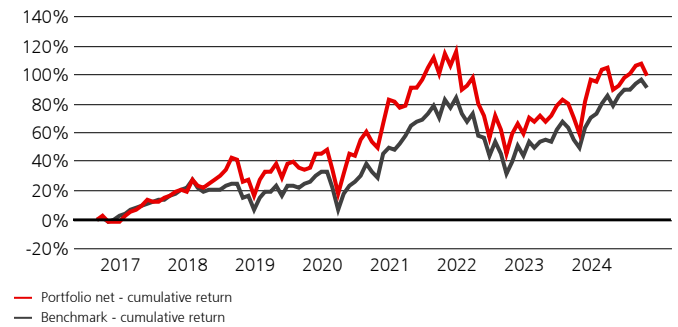
## Performance overview - monthly & cumulative

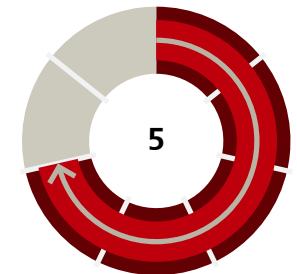

**Performance commentary**

The UBS (Lux) Security Equity Fund underperformed compared to the MSCI World ESG Leaders Index in the last month. Referring to our sub-themes, the strongest contributor was IT security, followed by transportation security. On the other hand, environmental security was the main laggard. On a company level, the main positive contributor was Cloudflare (IT security). The market reacted positively after a key hire of a strategic executive with deep product expertise and a strong enterprise focus. In addition, Illumina was another positive contributor after the company announced a new faster low-throughput, next-generation sequencer. On the other hand, the main detractor was Eurofins Scientific (health prevention). The company provided a cautious guidance, mainly in the field of biopharma.

**Market comments**

Global equity markets declined in October, we think mainly driven by the following factors: 1) US September labour market data came in stronger than expected, 254,000 jobs were created in September, well above the consensus forecast of 150,000, and the unemployment rate fell to 4.1% from 4.2% in August. 2) Geopolitical tensions in the Middle East increased after Iran launched a barrage of missiles on Israel in response to Israel's assaults on Lebanon. 3) The People's Bank of China (PBoC) started with an aggressive easing package, including various rate cuts, broader property support and new liquidity tools for capital market. 4) Inflation rate in the eurozone slowed to 1.8% in August, while in the US, the same number fell to 2.4%. 5) The European Central Bank (ECB) lowered interest rates for the third time this year by 25 basis points, bringing its policy rate to 3.25% as price pressures across the eurozone fade rapidly. In China, the PBoC cut its benchmark rates by also 25bp as part of an ongoing stimulus. (Bloomberg)

Notable news from the security and safety sector:

- Swissmedic, the Swiss surveillance authority for medicines and medical devices, conducted medical device inspections in 25 Swiss hospitals. The checks again revealed a need for action in all inspected areas, particularly in quality management, maintenance, the basic and further training of the personnel involved, as well as the infrastructure of the reprocessing departments. The identified deviations have an impact on device safety, and thus on the safety of patients (Swissmedic, 7.10.2024).
- The Chinese hackers who burrowed into the networks of US telecommunications firms have used their deep access to target the phones of former President Donald Trump, JD Vance and people affiliated with Vice President Kamala Harris' presidential campaign. It was not clear what data the hackers were able to obtain. The hackers are believed to be tied to China's intelligence services. The boldness of the hackers' activities, the vast breadth of the espionage and the timing of the attacks weeks before the presidential contest have some officials worried about the possibility of a far more significant effort to interfere or disrupt the election, some people said according to the WSJ. Experts who track foreign influence efforts say the days right before an election are the most vulnerable to attack, as the proximity to voting leaves little time to mount a response (The Wall Street Journal, WSJ, 26.10.2024).
- An E. coli outbreak at McDonald's had infected 90 people, leaving 27 in hospital and one person dead. The outbreak is appeared to be connected to fresh sliced onions and beef patties as the contaminated ingredients (Financial Times 24.10.2024, CNBC, 30.10.2024).

The recent incidents show that prevention is the best strategy for mitigating security and safety risks.

**Comments on transactions**

As usual, we did some rebalancing.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
