## Investment Policy

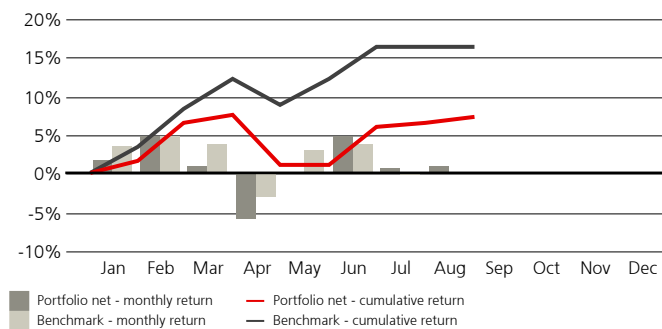

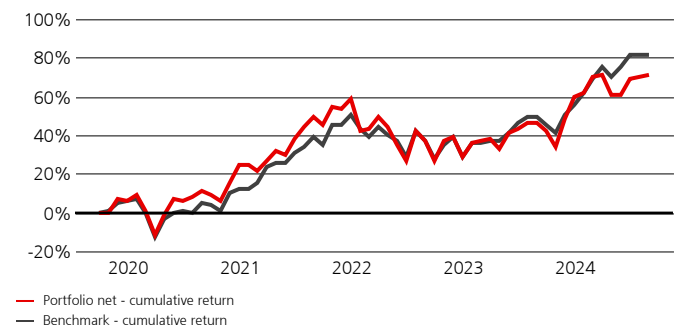
## Performance overview - monthly & cumulative

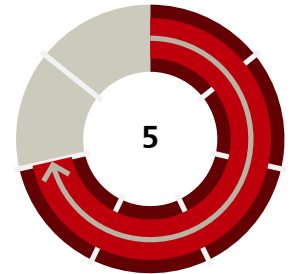

## Performance commentary

The UBX (LUX) Security Fund outperformed compared to the MSCI World ESG Leaders Index in the last month. Referring to our subthemes, the strongest contributor was IT security, followed by crime prevention. On the other hand preventive health was the main laggard. On a company level, the main positive contributor was Fortinet (IT Security), which published better-than-expected quarterly results, while on the other hand, the main detractor was Okta (IT Security), mainly driven by cautious guidance due to the uncertain macroeconomic environment.

## Market comments

Global equities and particularly the Japanese equity market corrected sharply at the beginning of August due to a combination of US recession fears and the strength of the Japanese Yen as the Bank of Japan increased interest rates. However, the Nikkei 225 recovered most of its losses (in JPY) terms and the global equity markets closed August in positive territory. The main drivers were as follows: 1) The US July employment report contained significant downside surprises, with non-farm payrolls increasing by only 114,000 and the unemployment rate rising to 4.3%. 2) The inflation rate in the eurozone stood at +2.6%, while in the US, it was 2.9%. 3) On the monetary policy side, the US Federal Reserve kept interest rates on hold. Chair Jerome Powell said that the "time has come for policy to adjust". He added that "confidence has grown that inflation is on a sustainable path" back to the central bank's 2% target (keynote speech at Jackson Hole economic conference, 23.08.2024). (Bloomberg)

Notable news from the security and safety sector:

The World Health Organization (WHO) has declared the highly infectious disease Mpox (formerly known as monkeypox) a global health emergency. It has now spread across parts of central and east Africa. Scientists are concerned about how fast a new variant is spreading and its high fatality rate. By declaring the Mpox outbreak as a public health emergency, it is hoped research, funding and the introduction of other international public health measures will be accelerated (WHO, 14.08.2024).

Toyota Motor confirmed a hack after data allegedly stolen from the company was posted online. A threat actor leaked an archive of 240GB of data stolen from the company's systems on a hacking forum. The automaker said the breach was "limited in scope", providing no further details. The incident follows a ransomware attack at Toyota's financial services unit in December 2022 and three instances of misconfigured cloud services that resulted in leaked data dating back years (BleepingComputer, 19.08.2024).

The Swiss canton of St. Gallen has measured high PFAS levels in the meat of some cows and cattle. It stopped the sale of the food in question. The St. Gallen government is calling for a national action plan to deal with the persistent chemicals (Neue Zürcher Zeitung, 29.8.2024). These examples show the critical nature of security and safety.

## Comments on transactions

As usual, we did some rebalancing.

## Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
