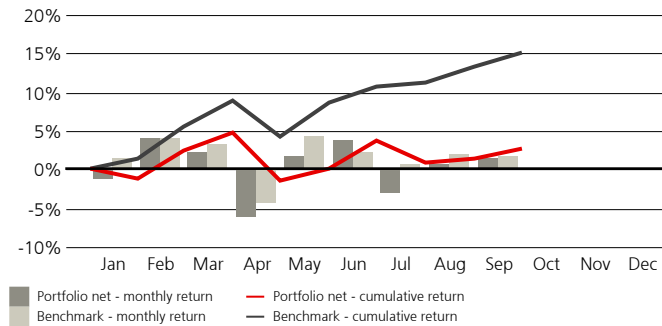
Investment Policy

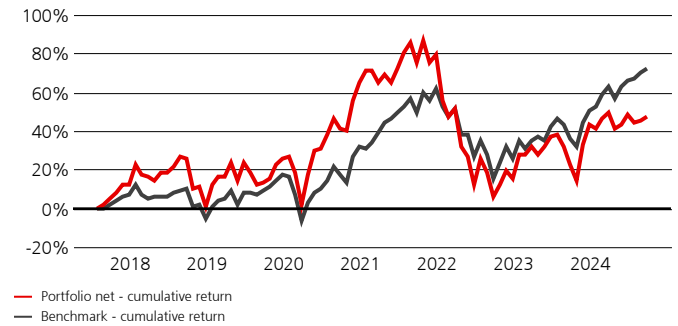
Performance overview - monthly & cumulative

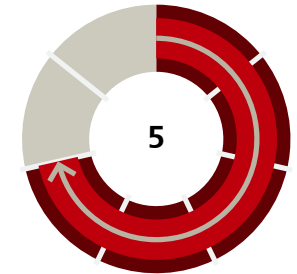

Performance commentary

The AI & Robotics strategy underperformed the benchmark in the quarter. Top performers in the fund were asset tracking companies Samsara and Impinj with good results, and products showing increasing traction. Impinj is sounding increasingly bullish on opportunities in the food packaging space for their RFID technology (Goldman Sachs conference, 11.09.2024). Valmet received a large order from a Brazilian customer (press release, 24.09.2024), boosting the stock into quarter end, and Supcon, our Chinese process automation play, rallied over 30% with the China market on the government stimulus plans. The underperformance of the semiconductor tools sub-segment played a significant role in fund underperformance in the quarter. Camtek, ASML and ASM International all featured in the bottom five contributors for the quarter, highlighting the mood shift that occurred from late July onwards. The other two names which were weak on idiosyncratic issues were Dexcom and Mobileye. Dexcom fell heavily after signalling they had not added as many new patients as expected and that there were some issues in their distribution channels. Mobileye fell on weak China demand and signs that higher priced products, key to the longer term story, are struggling to gain traction.

Market comments

Global equity markets gained about 5% in the third quarter as measured by the MSCI ESG Leaders Index. Markets sold off heavily in July and the first half of August as fears of slowing growth in the economy took hold, only to reverse sharply through August before, again, selling off in early September. After the Federal Reserve delivered a 50bp cut to interest rates (press release, 18.09.2024), marking the start of the easing cycle, markets again calmed and rose to new highs by the end of September. Adding to the good mood, a late September stimulus package in China led to a huge China equity market rally from depressed levels.

In AI & Robotics, a lot of focus is turning to the return on investment from artificial intelligence (AI) infrastructure spending and monetisation of AI use cases. So far it is fair to say we are still waiting to see the answer, but there is no indication of a slowdown in spending on key infrastructure like AI servers, as shown by robust results from Nvidia and Micron in recent weeks.

We see AI being infused into many leading companies' products to enhance and augment user experiences. Nonetheless, we have seen a pause in the AI infrastructure trade in the stock market with semiconductor equipment stocks pulling back substantially since July on uncertainty around spending from Intel, risk of further restrictions on sales to China and muted recovery in non-AI memory markets. At the same time, interest rate cuts open the door for rotation towards more rate-sensitive parts of the economy. However, the picture in a number of these areas like auto, life science tools and general industrial remains rather lacklustre for now with the auto sector in particular experiencing tough times as evidenced by profit warnings from a number of key producers like Ford (24.07.2024), BMW (10.09.2024) and Volkswagen (30.09.2024). Manufacturing downturns as shown by the Global Purchasing Managers' Index (PMI) should ultimately be aided in their recovery by global stimulus efforts particularly as inventory levels normalise, benefiting automation providers.

Comments on transactions

Key transactions in the quarter included a more cautious stance on semiconductor equipment companies. Given large position sizes and considerable exposure to the space, we trimmed position sizes in ASML, ASM International, KLA Corporation and sold BE Semiconductor. These are high-quality companies operating in an attractive and consolidated industry where we want to maintain exposure, but in the short term there are some headwinds so we have taken some profit while these play out. We did, however, top up Camtek and Lam Research where the peak-to-trough sell-off reached 35%–45%, a level we feel more than reflects the industry headwinds (Bloomberg, Camtek in the period between 08.07. and 18.09.2024, Lam Research in the period between 10.07. and 10.09.2024). Mobileye, as discussed, suffered heavily on a second profit warning of the year where the slower ramp in their higher-value products is a change to our thesis, and we sold the stock on the end of quarter rebound. We also topped up traffic automation company Verra Mobility, automated paper machine company Valmet and rate-sensitive names Autostore and Bill Holdings where the stocks have priced in a lot of negative news, while taking profit in Impinj, Inspire Medical and Samsara following strong performance.

Top 10 positions - ESG Characteristics











Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
