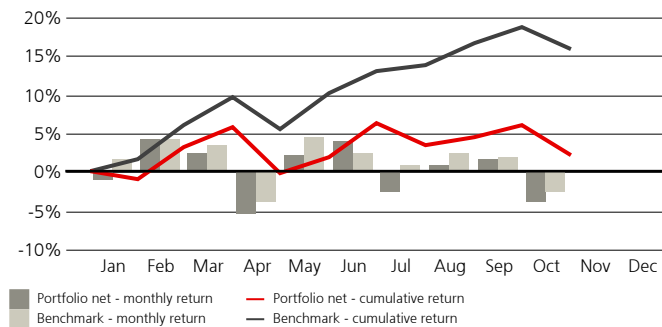
Investment Policy

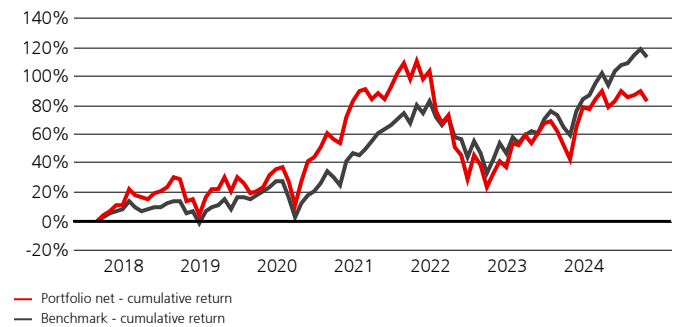
Performance overview - monthly & cumulative

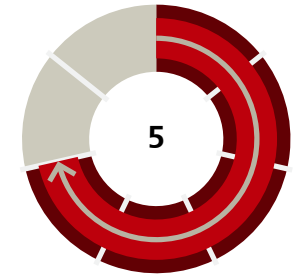

Performance commentary

The fund underperformed the benchmark in October. Nvidia was the largest absolute positive contributor for the month with the stock again rallying to new highs. The commentary on demand for AI chips continues to be positive allowing the stock to, so far, keep performing in the run-up to their earnings announcement on 20 November. Other positive contributors to performance include IT automation software names Datadog and ServiceNow, aided by good quarterly results at the latter (23.10.2024). On the negative side, we see a picture where AI chips are really the only area of semiconductors where demand is strong. Chip equipment company ASML disappointed with a substantial profit warning for 2025 when it reported Q3 2024 results (company web page, 16.10.2024). This caused a substantial share price correction across all equipment makers and explains the appearance of ASML, ASM International, KLA Corporation and Jenoptik (component supplier to ASML/KLA) in the negative contributors for the month.

Market comments

October saw equity markets dip into negative territory with a late month sell-off but the bigger picture is new high water marks in global equities, driven by US stock markets. While much of the chatter is about the November US election, it is not especially clear this has had a meaningful impact on stocks yet. In artificial intelligence (AI), investors are keen to see evidence that the billions of dollars being invested in AI infrastructure is starting to produce returns. To this end, the cloud businesses at Amazon, Microsoft and Google reached nearly \$63bn in Q3 of 2024, a growth of 22.2% on the same period last year and the fourth consecutive quarter of accelerating growth (Jefferies research, 01.11.2024). This is important for many of our companies like Nvidia providing the chips, or IT automation software companies Datadog or Dynatrace, where they are beneficiaries of accelerating growth in cloud revenues. In other news, the strength of the AI & robotics theme was again highlighted by a major company, in this case Tesla, hosting its "We, Robot" event where they unveiled further functionality and products in both humanoid robots and self-driving vehicles. While we know to approach Elon Musk's comments with caution, what is clear is that these are major trends and development platforms that continue to move closer to wider adoption. While it is often the megacap (non-pure play) companies leading the commercialisation of technology, under the hood we find lots of smaller interesting pure play investment opportunities supplying critical components or technology.

Comments on transactions

We continued taking profit in semiconductor tools names in October, both before and after the ASML newsflow. This has been one of the best performing sub-themes over the last three years. ASML has been sold from the portfolio, while we view it as a high-quality and hugely important technology company, we recognise that there are currently both company specific and industry headwinds. We also took profit to reflect these views by reducing position sizes in ASM International, Cadence Design and Synopsys while locking in some of the large gains in Nvidia, Impinj and Samsara. Against this we are building new positions in a leading provider of automation to the food industry as well as in IT automation software providers in both customer facing and cybersecurity related end markets. Finally, we have been adding to BILL Holdings, another IT automation software company where valuation appears attractive and the company is exposed to a large opportunity in automating financial processes at small and medium-sized businesses.

Asset breakdown by ESG rating



Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
