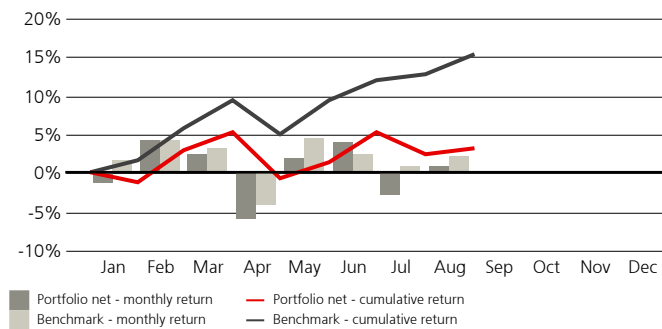

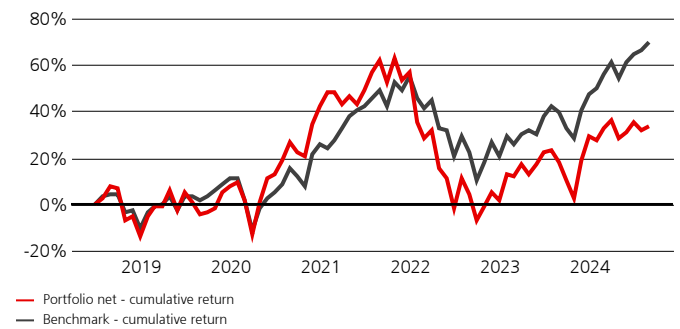
## Performance overview - monthly & cumulative

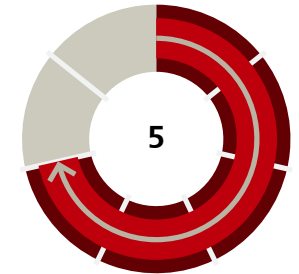

## Performance commentary

The AI and Robotics strategy delivered positive returns in August, though slightly lagged the broader market. Equity markets traded off sharply early in the month before recovering and finishing in positive territory. The Japanese Topix Index fell 12% on t5 August and the VIX, a volatility index, hit the 3rd highest reading since records began in 1992 (Jefferies Research, 05.08.2024). This caused a mini panic across global markets but, as is often the case, stocks rebounded and a few weeks later the short term disruption has largely been forgotten.

Within the fund, the top contributor was Inspire Medical, a sleep apnea device company, which rallied strongly on results. Ambarella, a designer of edge inference and autonomous driving processors, also rallied well off the lows on a good quarterly result. Marketing technology companies Zeta Global and Appier Group performed strongly due to the increasing adoption of AI-related advertising products. Negative contributors were from Mobileye, where China headwinds caused a second profit warning of the year, and from semiconductor equipment stocks like Camtek, as the AI hardware trade saw profit-taking, and Synopsys, the electronic design automation company which is also seen as an AI beneficiary.

## Market comments

A turbulent month in equities was marked by a short, heavy sell-off, followed by a prolonged and stronger rebound, messaging from Jerome Powell that about upcoming interest rate (speech by Chair Powell on the economic outlook – Federal Reserve Board, 23.08.2024) and another strong set of numbers from Nvidia (Nvidia earnings press release, 28.08.2024).

From an artificial intelligence (AI) perspective, Nvidia took centre stage and while they again beat expectations for the quarter and guided ahead of analyst consensus (Bloomberg), the short delay in the next generation product, Blackwell, led revenues to be guided a little shy of the highest whisper numbers. Big picture, this looks like a solid set of numbers with strong demand, but the stock had run well into the print and perhaps we need to see the set-up become clearer for the stock to see further gains. Other AI-related names have also been indicating a pause in the short term, with stocks generally failing to regain old highs despite the broader market regaining levels close to all-time highs (Bloomberg).

A nice example of AI & Robotics breaking new frontiers came from US start-up, Perceptive.io, which conducted the world's first fully automated dental procedure using a combination of imaging, AI algorithm analytics and robotics. The goal is to make procedures such as fitting a crown significantly faster, more accurate and safer. While not yet a regulatory approved process, this shows how technology innovations are opening up new opportunities (World Economic Forum, First fully automated dental surgery completed by robot, 12.08.2024). From a long-term perspective, we believe the secular trends for advancements in AI and Robotics are firmly set and likely to keep the theme at the forefront of investors' minds.

## Comments on transactions

After the early-month sell-off, we reinvested cash into the market in areas that had been heavily penalised. These included semiconductor-related names such as Nvidia, Camtek and Lam Research. This was validated by their subsequent strong recovery with the market. However, as we enter September there is plenty of uncertainty around how fast the economy is cooling off and how this may impact recoveries across a range of technology and industrial end markets. Intel cut its capex forecast for 2024/25 (Intel Second Quarter Financial Results, 01.08.2024), which appears to be largely a company-specific issue, but also hints at an emerging risk to the semi equipment recovery trend. With this in mind, we again took some profit, towards the end of the month in ASML, ASM International, BE Semiconductor, as well as in Impinj, Inspire, Samsara and Ambarella. More stable, predictable cash flow companies, such as traffic automation system vendor, Verra Mobility were increased.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
