

#### **Investment Policy**

The investment universe encompasses companies that provide the facilities and services necessary to maintain and develop modern infrastructure, and also includes companies supplying infrastructure-related products and services. The objective is to maximize total return from capital appreciation and dividends over extended periods of time. It follows an unconstrained, non-benchmark oriented approach to identify attractively valued companies positioned to benefit from the infrastructure theme.



### Performance commentary

The fund outperformed the broader equity market as measured by the MSCI World (NR) Index. In the quarter, National Grid was the largest contributor, up +23% (in USD), recovering from the negative stock price reaction after the company disclosed a GBP 7bn capital raise to fund its next capex plan which aims to decarbonise the UK energy networks over the next five years (National Grid Press Release, 23.05.2024). The German company E.ON was the second top contributor, up +13% (in USD), on no particular news. American Tower was also among the stronger performers, up +19% over the quarter, benefiting not only from favourable Q2 24 results and an increase in its annual guidance, but also from a rotation towards long-duration infrastructure companies (American Tower earnings call, 30.07.2024). In contrast, waste management was among the worst detractors over the quarter, down -2%, as the company's Q2 24 results missed consensus on adjusted earnings per share (EPS) and earnings before interest, taxes, depreciation and amortisation (EBITDA) levels due to softness in industrial waste volume and an unexpected one-time charge (Waste management Q2 24 earnings call, 25.07.2024).

#### **Market comments**

Over the quarter, equity markets initially fell amid a rotation out of big tech into laggards as quarterly results have left investors increasingly concerned about the pace and timing of future artificial intelligence (Al) revenues and what this could mean for further investment in Al infrastructure. However, from early August, equity markets recovered after Federal Reserve Chair Jerome Powell signalled the central bank's intention to cut the interest rate. On 18 September, the Fed kicked off its easing cycle with a 50 basis point cut, delivering a strong message that the central bank was not hesitant to act aggressively to ensure a soft landing (Reuters, 18.09.2024). Infrastructure stocks outperformed the broader equity market (source: Bloomberg, NMX Infrastructure Composite Index, MSCI World [NR] Index) during this period. Among the various sub-themes: data centres, electric and water utilities, midstream, renewables and tower REITs performed best. Conversely, airports, railways and waste utilities were found at the bottom end of the ranking. While midstream benefited from mergers & acquisitions (M&A) activities over the quarter, data centres, towers REITs and utilities profited from the decline in US bond yields.

#### **Comments on transactions**

During the quarter, we continued to rebalance the portfolio by reducing the weighting of cyclical transportation and midstream stocks in favour of more interest rate-sensitive utilities and communications infrastructure. Moreover, we added, among others the following companies to the portfolio: American Water Works, Crown Castle, Public Services Enterprise and SBA Communications. To finance these new positions, we exited Athens International Airport, the two Mexican Airports - Pacifico and Sureste - and RWE. The rationale for the switch was to reduce exposure to cyclical sectors and gain exposure towards regulated utilities and communication technologies which, in our view, benefit from the positive forecasted effect of discount rates. Lastly, we sold the entire position in Neoen, as the French renewable operator received a take-over offer, which is expected to be completed by December 2024 (Neoen press release, . 25.06.2024).
