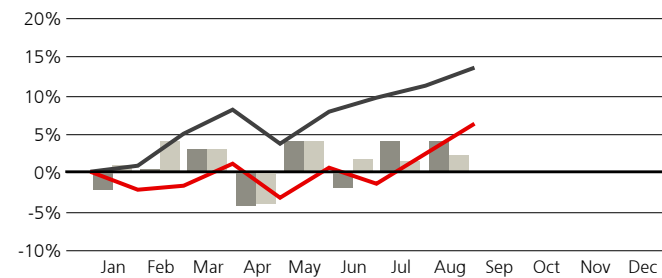
## Investment Policy

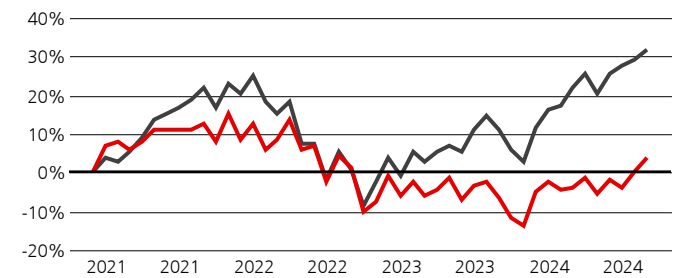

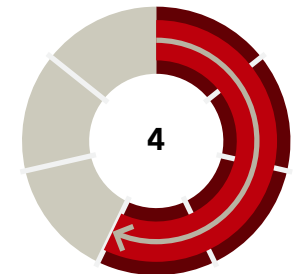

## Performance commentary

The fund outperformed the broader equity market as measured by the MSCI World (NR) Index in the reporting period. In August, ONEOK was the largest contributor, up +12%, as the US pipeline operator announced the acquisition of the private firm Medallion Midstream and the purchase of a controlling interest in EnLink, both from Global Infrastructure Partners. The transactions represent a combined value of USD 5.9bn (ONEOK Press Release, 28.08.2024). Targa Resources was the second strongest performer, up +8% over the month, as it reported Q2 adjusted earnings before interest, taxes, depreciation and amortization (EBITDA) almost 6% ahead of consensus, driven by record-high fractionation, natural gas liquids (NGL) transportation and Permian volume. Moreover, Targa raised its annual adjusted EBITDA guidance by 5% (at the midpoint) and announced an additional USD 1bn share buyback programme (Targa Q2 24 Earnings Results, 01.08.2024). In contrast, Grupo Aeroportuario del Sureste was the largest detractor over the month, down -10%, as the airport operator disclosed an -11% drop in passenger traffic in July 2024 in Mexico, one of the company's largest markets (Grupo Aeroportuario del Sureste Press Release, 05.08.2024).

## Market comments

US equities ended August on a high note as Federal Reserve Chair Jerome Powell signalled the central bank's intention to cut interest rates as "confidence has grown that inflation is on a sustainable path" back to the US central bank's 2% target (Keynote speech, 23.08.2024). Infrastructure stocks outperformed the broader equity market (source: Bloomberg, NMX Infrastructure Composite Index, MSCI World [NR] Index) during this period. Among the various subthemes midstream, electric utilities, waste recycling and tower REITs performed best. Conversely, airports, railroads, as well as renewables and water utilities were found at the bottom end of the ranking. Among others, midstream benefited from mergers & acquisitions (M&A) activities while emerging market-exposed tower REITs lagged behind the infrastructure sector in August.

## Comments on transactions

In August 2024, we sold the entire position in Neoen, as the French renewable operator received a take-over offer, which is expected to be completed by December 2024. We also sold our entire position in RWE and reduced the overweight in E.ON – two German utilities, to increase exposure to US regulated utilities. In addition to adding Duke Energy to the portfolio, we scaled up holdings in Entergy Corp, Southern Co and Public Service Enterprise. The switch was based on relative valuation and the positive expected effect of discount rates on regulated utilities. Similarly, we trimmed the overweight in Spanish airport operator Aena in favour of telecom towers operator American Tower, due to cyclical and valuation-related considerations.

## Top 10 positions - ESG Characteristics













## Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
