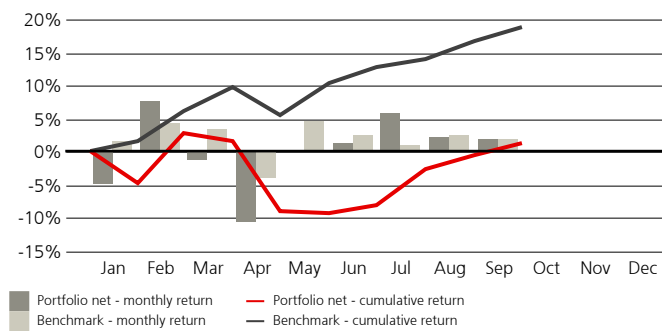
## Investment Policy

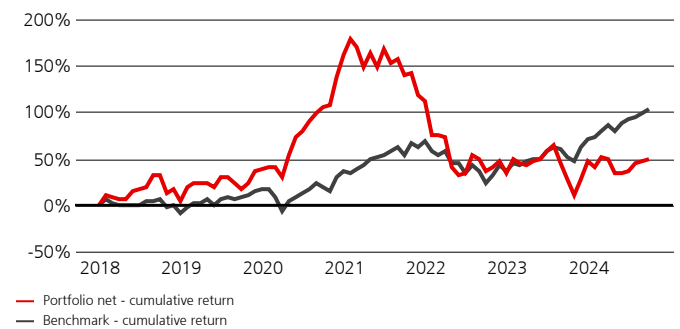
## Performance overview - monthly & cumulative

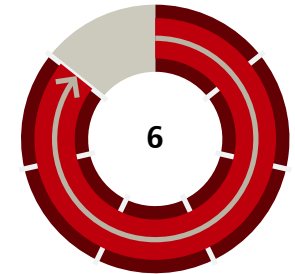

## Performance commentary

Our strategy strongly outperformed the benchmark in Q3, driven by strong rebound of the efficiency sub-theme and continued robust performance in the treatment sub-theme. The top three performance contributors were Inspire Medical, Exact Sciences and Zai Lab. Inspire delivered a strong beat-and-raise Q2, defying market concern around GLP-1 impact with reassuring margin trends. Exact Sciences posted strong Cologuard growth and improving margin in Q2, followed by an encouraging blood-based colorectal cancer screening test clinical trial in September. Zai Lab had a strong rebound after China stimulus announced at the end of September. The top three performance detractors were Dexcom, iRythm and Arrowhead. Dexcom slumped after major execution hiccups in Q2. iRythm was weak due to lingering overhang around US Food and Drug Administration (FDA) inspection on its manufacturing facilities, but fundamentals were strong. Arrowhead was weak due to financing concerns which were later relieved.

## Market comments

Q3 was a bumpy ride towards another all-time high for major equity indices. Softer US inflation prints in June and cooler July non-farm payroll drove markets out of growth names into small and mid cap names in July, leading to Digital Health strategy outperformance. This was quickly followed by a sharp sell-off in early August amid concerns of a hard landing in the US and fear that the FED was behind the curve. But markets quickly rebounded as the FED soon reaffirmed its intention to cut rate in September as well as its strong willingness to support a strong labour market. As the FED commenced with a 50bp cut in September (Press Release, 18.09.2024) and markets continued to price in further cuts in the remainder of the year, the soft-landing narrative remained intact, which supported another strong equity market performance in September.

## Comments on transactions

We did not enter or exit any positions in Q3. We continued to do rebalancing alongside market volatilities.

## Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
