


Performance overview - monthly & cumulative

Performance commentary

Performance of the UBS (Lux) Digital Health Equity Fund was close to the benchmark over the month of August 2024. As the earnings season was progressing, there were significant winners and losers in the strategy. Exact Sciences, the company selling the non-invasive colorectal cancer detection test, performed strongly as they pointed to a better free cash flow situation. Inspire Medical, which treats sleep apnea, has preannounced positive revenue figures and has shown impressive operating leverage. Evolent Health in the field of cost management (part of the Efficiency sub-sector) was strong after good margin progression as well. On the other hand, Twist, Guardant Health, and Arrowhead Pharmaceuticals were the biggest detractors. Despite the macro situation being more supportive with regard to interest rates, those companies are still loss-making and therefore were less attractive in investors' minds in the short term.

Market comments

Equity markets showed a decent performance over the month of August 2024, as measured by the MSCI World ESG Leaders (NR) Index, while initially dropping over -6.5 % in the first week of August (Bloomberg, data until 05.08.2024) due to US recession fears. Clearly, conflicting signs from the labour market has made the Federal Reserve Board more akin to begin lowering rates in September. At the same time, there is still no evidence suggesting that the economy would decelerate very quickly and enter a hard landing scenario.

Comments on transactions

The fund was very active in rebalancing its holdings. This occurred particularly as exposure to a single company exceeded 4%, which is generally the point at which we aim to bring back holdings close to 4%. On the flipside, companies which had a significant correction were often increased in weight to lower the average purchase price. Over the month, there have not been any new positions established or complete sales.
