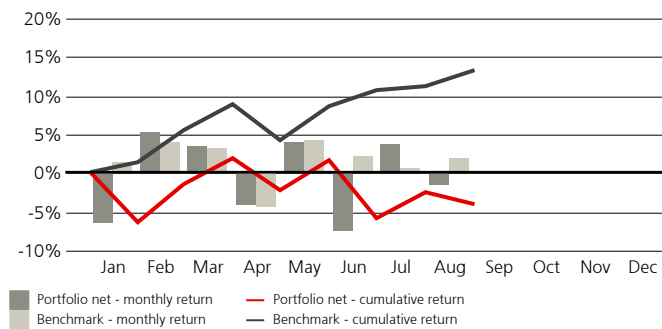

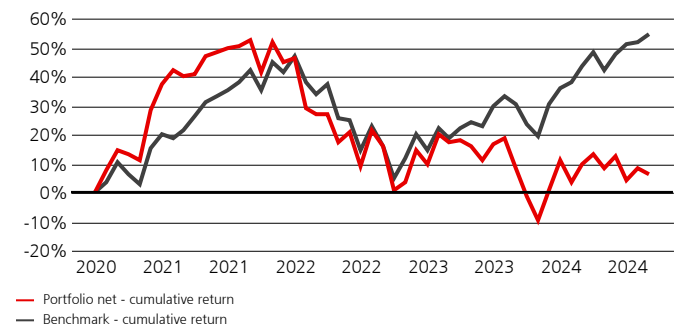
Performance overview - monthly & cumulative

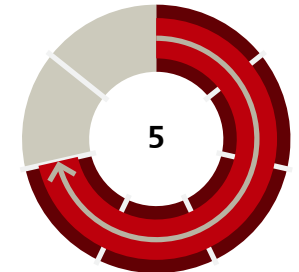

Performance commentary

The fund lagged the benchmark in August. From our subthemes, resources performed best driven by gains for Novonesis, Corbion and Voltronic Power. Novonesis reported better-than-expected results and raised its full year guidance, backed by 10% organic sales growth in Q2 amid strong demand for biosolutions across all segments and especially in household care and food & beverage markets (Q2 earnings call, 28.08.2024). Similarly, Corbion was up after reporting its second consecutive quarterly beat on earnings before interest, taxes, depreciation and amortization (EBITDA), underpinned by a healthy demand for its algae nutrition offering to aquaculture and new customer wins around clean label formulation in food preservation. Despite sluggish end markets for its bio-plastics solutions, the company reiterated its guidance due to strength in the aforementioned end markets. Voltronic Power benefited from continuously strong demand for Solar Inverters from South Asia and Middle Eastern countries. Sustainable Infrastructure performed weak in the month, driven by weakness in building-related stocks like Installed Buildings Products and Advanced Drainage Systems (WMS). Although the former continues to benefit from its elevated backlog and referred to a healthy mergers and acquisitions (M&A) pipeline as the top priority in its capital allocation strategy, trends in multi-family housing and light commercial markets are expected to moderate in the second half of the year. End market trends at WMS remained largely on track, except for the currently choppy agricultural business, which caused weaker first-quarter top-line results. In waste mitigation, performance was mixed, with composite decking provider TREX down, as soft demand in the entry-level product category is causing cautious re-stocking among distributors (Q1 2024 earnings call, 06.08.2024). Carbon reduction technologies performed relatively better, helped by the continued rebound of Nordic Semiconductor on reportedly improving demand for Internet of Things (IoT) solutions (Q1 2024 earnings call, 08.08.2024).

Market comments

Stock markets were mostly higher in August, with the S&P 500 Index up 2.4%, outperforming the Nasdaq. Although small caps underperformed with the Russel 2000 Index down 1.5% in the month, some early signs of a broadening market performance emerged with several rotation attempts underway in recent weeks (Bloomberg, 02.09.2024). Investors remained focused on any evidence of easing inflation and an improvement of corporate profits to support a sustained rotation into small and mid caps. Given the labour market's recent weakness, highlighted by the uptick in July's unemployment rate, and the July consumer price index (CPI) confirming inflation within the target range, Federal Reserve Chair Jerome Powell signalled the central bank's intention to cut interest rates next month for the first time since the pandemic (UBS, Stocks near all-time high amid positive outlook, 27.08.2024). Stronger consumer spending highlighted in the revised gross domestic product (GDP) figures, coupled with declining jobless claims, should help alleviate fears of an imminent recession, which should support the soft-landing scenario of most investors.

In terms of demand trends for climate solutions, US electricity generation increased by 20.2 gigawatts in the first half of the year, the largest rise in more than two decades, to meet the growing electricity demand of data centres and the overall electrification trend. The additions are expected to more than double to 42.6 gigawatts by the end of the year, with the bulk expected to come from carbon-free power sources, including solar and battery storage. (Bloomberg, 19.08.2024). While growth in electric vehicles (EV) sales slowed in Europe, market penetration in China continued to rise with leading players like BYD recording a 36% increase in units sold in August compared to last year (Wall Street Journal, 02.09.2024).

In August we kept the positioning of the climate solutions strategy largely unchanged.

Top 10 positions - ESG Characteristics










Asset breakdown by ESG rating







Carbon emission intensity contribution by GICS sector






Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO ₂ -equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
