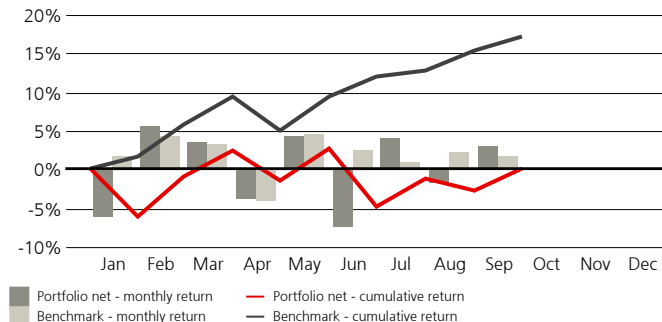
Investment Policy

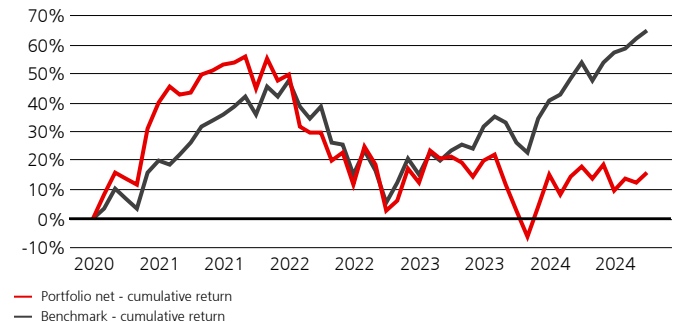
Performance overview - monthly & cumulative

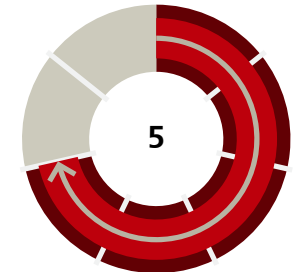

Performance commentary

The fund outperformed the benchmark in the third quarter of 2024, driven by the outperformance in July and September, partly offset by underperformance in August.

During the quarter, three out of four sub-themes contributed positively. The resources sub-theme delivered the strongest contribution with Corbion, Novonesis and Nordex as top contributors. Corbion was up after reporting its second consecutive quarterly beat on earnings before interest, taxes, depreciation and amortisation (EBITDA), underpinned by healthy demand for its algae nutrition offering to aquaculture and new customer wins around clean label formulation in food preservation. Similarly, Novonesis reported better-than-expected results and raised its full-year guidance, backed by 10% organic growth in Q2 amid strong demand for biosolutions across all segments and especially in household care and food & beverage markets (Novonesis earnings call, 28.08.2024). Nordex' Q2 results showed strength in underlying demand, with orders up 31% in the first half of the year, stable pricing environment and installation pace versus previous year (Nordex earnings call, 25.07.2024). In the sustainable infrastructure sub-theme, Pentair, Installed Building Products and Acuity Brands led the positive contributions to return. Waste mitigation saw Biotage and Valmet as top contributors. Biotage reported a strong set of quarterly numbers both on organic growth and gross margins (Biotage Q2 earnings call, 16.07.2024), with the company's recent acquisition showing continued strength. Valmet rallied after booking a significant order in September. Carbon Reduction Technologies detracted from performance, with Nordic Semi and MYR Group being the top detractors. Nordic Semi dropped after the CEO's comments on the company's short-term demand expectations during the company's Capital Markets Day on 26.09.2024, while MYR Group fell after its second-quarter results missed estimates, owing to lower revenue and higher-than-expected costs in its Transmission and Distribution segment. On the other end, Yadea and BYD posted strong quarterly performances and stood out as top contributors in the sub-theme.

Market comments

Stock markets traded higher during the third quarter. In the US, the S&P 500 secured its fourth consecutive quarter of positive returns – the longest winning stretch since 2021 (Bloomberg, 01.10.2024) – delivering 5.5% in the third quarter. Small caps had a strong quarter, with the Russell 2000 posting a gain of 8.9% and the equal-weight version of the S&P 500 logging a 9.1% return in Q3, reflecting a broadening of market participation, after a first half of the year where the equal-weight version of the S&P 500 had the largest first-half underperformance on record (Bloomberg, 29.06.2024). (Factset, 01.10.2024) Corporate profitability backdrop in the US remained healthy, with S&P 500 firms delivering a second-quarter earnings growth of 11.3% year-on-year (YoY) and 80% of the companies beating earnings estimates. In Europe, the Stoxx 600 was up 2.2% in the third quarter, with retail, utilities and telecom posting double-digit returns. (Factset, 01.10.2024) On the monetary policy front, central banks lowered interest rates over the quarter, with the Federal Reserve in the USA delivering a 0.50% rate cut in September, signalling a shift in its focus from price stability to the other half of its dual-mandate, maximum employment (The New York Times, 19.09.2024). In Europe, the easing cycle is also underway, with the European Central Bank cutting rates twice by 0.25% – in June and September – bringing the key deposit rate to 3.5% (Factset, 01.10.2024); the Bank of England, Swiss National Bank and Riksbank also reduced rates by 0.25% during the quarter. In China, the People's Bank of China adopted a slew of measures aimed at reviving its economic growth, leading the Chinese market to surge by more than 20% from mid-September through the end of the month (The Economic Times, 30.09.2024).

During the quarter, the US Environmental Protection Agency (EPA) announced a final rule to establish a new programme to better manage, recycle and reuse climate-damaging hydrofluorocarbons (HFCs) under the American Innovation and Manufacturing (AIM) Act. The EPA's final rules come less than two years after the US ratified the Kigali Amendment to the Montreal Protocol, helping the country achieve an 85% HFC phasedown by 2036 (EPA, 23.09.2024). On a different note, in September we saw natural disasters impacting Europe, Asia and the US. Besides the unbearable cost of human lives, the estimated financial costs of these events are significant: USD 10 billion as a result of floods in the Czech Republic and Poland (Reuters, 20.09.2024), USD 3.3 billion caused by Typhoon Yagi in Vietnam (Reuters, 28.09.2024) and over USD 100 billion as a consequence of Hurricane Helene (Fortune, 29.09.2024)

Comments on transactions

During the quarter we added to the recently initiated position on Scatec and exited our positions on Signify and Ebusco. We exited Signify to reduce our total exposure to the energy efficient lighting market, as we have a higher conviction in competitor Acuity Brands, owing to the company's superior margins, growth profile and market position in North America. Ebusco failed to show signs that it could execute on its turnaround plan, and the company's order flow remained subdued.

Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
