

Investment Policy


The fund assets are invested worldwide following a thematic approach across all our high-conviction themes. We currently invest in six high growth themes: security and safety, robotics and automation, innovative healthcare, environmental technologies, infrastructure, and energy transition. These thematic equity strategies are supported by a number of long-term structural growth drivers, such as increasing digitalization and connectivity, globalization and demographic trends, the need for productivity and efficiency, as well as the emergence of millennials' values. Within these themes, we invest in companies with a "pureplay" focus, which we define as having at least 50% revenue exposure directly attributable to their investment theme.

Performance commentary

The fund performed broadly in line with the benchmark. Security, digital health, robotics and infrastructure outperformed the benchmark on a relative basis while energy evolution and environmental impact lagged. The top contributing single stocks were NuScale Power, Natera and Bill Holdings. NuScale Power, a provider of small modular reactor technology, was up amid a heightened interest in the technology from data centre developers who are looking for a clean, reliable power source. Shares in Natera, a provider of cancer recurrence monitoring tests, climbed after the company reported a substantial revenue beat for the third quarter. Provider of accounting automation software Bill Holdings also reported strong quarterly numbers. The main detractors were Evolent Health, Nexans and Zeta. Shares in Evolent Health, a technology provider for value-based care, tumbled after the company reported weaker-than-expected quarterly earnings. Nexans, a major global player in the high-voltage cable industry, suffered after a placement of a big investor and amid a negative sentiment towards US onshore and offshore wind after Trump's election victory. Furthermore, the company's capital markets day failed to meet investors' expectations. Lastly, enterprise technology software vendor Zeta came under pressure in the wake of a short report.

Market comments

Global equity markets delivered positive returns in November. The narrative was dominated by the US presidential election and president-elect Donald Trump's subsequent comments on potential new tariffs, as well as the nomination of some of his leadership team. In healthcare, the nomination of Robert F. Kennedy Jnr. to lead the US Department of Health and Human Services led to volatility. The annual rate of inflation in the US increased by 0.2% to 2.6% (Bloomberg). The market performance broadened compared to previous months, with small cap stocks rallying and making up ground on large caps.

Comments on transactions

In order to equalise the weights of the sub-themes, we rebalance the fund typically once per quarter. In addition, throughout the month, we initiate and exit positions mirroring the investment decisions taken at the underlying theme level.
