
#### **Investment Policy**

The fund assets are invested worldwide following a thematic approach across all our high-conviction themes. We currently invest in six high growth themes: security, robotics, digital health, edutainment, environmental impact, and infrastructure. These thematic equity strategies are supported by a number of long-term structural growth drivers, such as increasing digitalization and connectivity, globalization and demographic trends, the need for productivity and efficiency, as well as the emergence of millennials' values. Within these themes, we invest in companies with a "pure-play" focus, which we define as having at least 50% revenue exposure directly attributable to their investment theme.



#### **Performance commentary**

In August, the UBS (Lux) Thematic Opportunities Equity Fund delivered positive absolute performance. However, on a relative basis it underperformed the benchmark. The best performing subthemes were infrastructure, security, and digital health. The weakest subtheme was energy evolution followed by environmental impact. In August, all the top single-stock contributors and detractors were from the digital health subtheme. Top contributors were Exact Sciences, Evolent Health and Transmedics. Exact Sciences, a provider of non-invasive colorectal cancer detection tests, saw an increase after indicating an improvement in the company's free cash flow. Evolent Health, a specialty care management provider, performed well after reporting a margin expansion. The organ transplantation service provider Transmedics continued its climb after raising its full-year guidance. The provider of liquid biopsy Guardant Health was the main detractor as investors question the guidance for their colorectal cancer blood test. Moderna was weak because of lower-than-expected orders of COVID-19 vaccines for the second half of 2024. Twist Bioscience lagged after announcing that one of their largest customers reduced orders.

#### **Market comments**

After a sharp sell-off during the first few days of the month, markets recovered quickly with most major indices finishing the month in the green. Factors that contributed to the short-lived correction include fears about a potential recession in the US and a stronger Japanese yen. Later in the month, economic data on inflation and the job market led to a quick recovery in many equity markets. In terms of the inflation rate, the US consumer price index dropped to 2.9% in July from 3% in June (Bloomberg). US Federal Reserve Chair Jerome Powell said the Fed is on the right path in the fight against inflation and that "the time has come for policy to adjust" (keynote speech at Jackson Hole economic conference, 23.08.2024).

#### **Comments on transactions**

In order to equalise the weights of the subthemes, we typically rebalance the fund once per quarter. In addition, throughout the month, we initiate and exit positions mirroring the investment decisions taken at the underlying theme level.
