

#### Investment Policy


The fund assets are invested worldwide following a thematic approach across all our high-conviction themes. We currently invest in six high growth themes: security and safety, robotics and automation, innovative healthcare, environmental technologies, infrastructure, and energy transition. These thematic equity strategies are supported by a number of long-term structural growth drivers, such as increasing digitalization and connectivity, globalization and demographic trends, the need for productivity and efficiency, as well as the emergence of millennials' values. Within these themes, we invest in companies with a "pureplay" focus, which we define as having at least 50% revenue exposure directly attributable to their investment theme.

#### Performance commentary

The fund outperformed the benchmark in the third quarter of 2024. On a relative basis, all sub-themes except for robotics contributed positively to the quarterly performance. The best-performing sub-themes were infrastructure and energy transition. In infrastructure we saw strength from our data centres, electric and water utilities and renewable companies. In energy transition the performance was mainly driven by stock selection within sectors. Robotics lagged because of the weakness in the semiconductor tools segment. In terms of single stock performance, top contributors were Exact Sciences, Inspire Medical and Contemporary Amperex Technology (CATL). Exact Sciences, a provider of cancer screening tests, was up after posting strong earnings and encouraging clinical trial results for a new product. Inspire Medical, a manufacturer of devices to treat sleep apnoea, beat their second-quarter earnings guidance and raised the guidance for the year. The battery producer CATL was up about 38% in September (Bloomberg) amid a stimulus-driven rally in Chinese stocks. Main detractors were Dexcom, Moderna and iRhythm. Dexcom, a provider of continuous glucose monitoring sensors, dropped after reducing its guidance on the back of a sales force reorganisation. Moderna was weak after reducing its long-term guidance and delaying the breakeven point. Lastly, iRhythm, a producer of cardiac rhythm monitoring devices, lagged because of lingering overhang around an inspection of its manufacturing facilities by the regulator.

#### **Market comments**

Global equity markets finished the third quarter in positive territory despite the volatility seen throughout the period. In August, weaker-than-expected data on the state of the US labour market triggered concerns about a hard landing, causing a sell-off in the market. However, markets quickly recovered as the US Federal Reserve (FED) confirmed a shift in its focus to the labour market. Finally, after keeping its target rate unchanged for more than a year, the FED cut rates by 50 basis points in September (Press Release, 18.09.2024), providing support for the soft-landing narrative. Furthermore, an unprecedented policy stimulus to the Chinese economy led to a strengthening in the yuan and a rally in Chinese stocks.

#### **Comments on transactions**

In order to equalise the weights of the sub-themes, we typically rebalance the fund once per quarter. In addition, throughout the month, we initiate and exit positions mirroring the investment decisions taken at the underlying theme level.
