
#### **Investment Policy**





#### **Performance commentary**

The fund underperformed its benchmark in August, mainly driven by stock selection effects within sectors. The top contributor to performance was Spanish renewable energy developer Acciona Energias Renovables, which showed a solid return after the sale of Spanish hydropower assets as part of its divestiture programme. Japanese renewable energy developer Renova also performed well, as it saw margins expand on the back of falling biomass fuel prices (wood pellets and palm kernel shells). Canadian miner Capstone Copper was another strong performer, continuing to deliver solid production growth. The worst performer in portfolio was US artificial intelligence battery software solutions provider Stem, which dropped significantly due to delays in renewable power projects impacting order intake, denting the company's growth. US silicon-carbide semiconductor manufacturer Wolfspeed also negatively impacted performance after the company delivered lower-than-expected earnings, while its new projects are taking longer to come into production.

#### **Market comments**

August got off to a bumpy start, as markets corrected in the wake of a yen carry-trade unwind triggered by the Bank of Japan hiking rates, and weaker-thanexpected manufacturing and employment data from the US. Volatility, however quickly subsided, and markets recovered after US Federal Reserve Chair Jerome Powell indicated a rate cut in September in his comments from the global central banker gathering in Jackson Hole, as inflation is heading in the right direction. The US dollar weakened during the month, as US yields came down significantly in August.

Defensive stocks were the best performers in August, led by the health care, consumer staples and utilities sectors. Information technology lagged the broader market as Nvidia earnings and guidance failed to impress, dragging down the overall sector. Oil prices declined slightly in August, despite continued tensions in the Middle East and a halt in Libyan oil production due to central bank issues in the country. The aluminium price rose strongly during the month, while copper remained relatively flat; lithium prices continue to be under pressure as electric vehicle battery demand is seeing its growth rate slow. Lastly, after similar moves by the US and European Union, Canada announced it impose a 100% tariff on imports of China-made electric vehicles, as well as duties on Chinese steel and aluminium (BBC, 26.08.2024).

#### **Comments on transactions**

During the month of August, the fund liquidated its position in Chinese electrolyte producer Guangzhou Tinci Materials, as overcapacity is still depressing prices and profits in the battery chemicals sector and might continue to be under pressure for some time. The fund established a new position in Canadian copper miner Lundin Mining, which has operations and projects in Argentina, Brazil, Chile, Portugal, Sweden and the US. Part of the position was also funded by reducing the position
