

#### **Investment Policy**



#### **Performance commentary**

The fund outperformed the benchmark in the reporting period. Performance was mainly driven by stock selection within sectors. The top contributor to performance was Chinese battery manufacturer CATL, which benefited from Chinese stimulus. French high-voltage cable manufacturer Nexans performed well as a resolution on the go-ahead of its Great Sea Interconnector pipeline between Cyprus and Greece is getting closer (Reuters, 21.09.2024). Chinese electric vehicle builder NIO surged as it received significant cash investments from key investors.

One of the worst performers in the portfolio was US artificial intelligence battery software solutions provider Stem, which dropped significantly due to renewable power project delays impacting order intake, denting the company's growth. US silicon-carbide semiconductor manufacturer Wolfspeed also negatively impacted performance after the company delivered lower-than-expected earnings, while its new projects are taking longer to come into production. French critical minerals miner Eramet lagged during the quarter on the back of domestic election uncertainty and discussions around tax hikes.

#### **Market comments**

The third quarter was a volatile one, with global equity markets dropping significantly both at the turn of July into August and again in August to September, only to exit the quarter around new highs. In September, the US Federal Reserve finally came with its long-awaited rate cut, as inflation targets are within reach and the signs of a weakening labour market mounted. The European Central Bank also lowered its policy rate in September as the European economy is seeing activity slow down drastically. After having lowered rates in August, the Bank of England left rates unchanged at its September meeting. The Bank of Japan, on the other hand, left rates unchanged in September, after having hiked rates in July. As US interest rates came down, the US dollar depreciated versus most other currencies, and gold rallied to new highs.

In a bazooka-like move, the People's Bank of China unveiled an unprecedented policy stimulus to the faltering Chinese economy, lowering banks' reserve requirements and reducing key policy and deposit rates. As a result, the yuan strengthened versus the dollar, and Chinese stocks rallied sharply towards the end of the guarter.

Also in September, former central banker Mario Draghi published his report on the future of European competitiveness, with recommendations for innovation in advanced technologies, decarbonisation and increased political security through reduced dependencies. Meanwhile, adding to Sino-American trade tensions, in September the US announced new tariffs on a wide range of Chinese goods: a 100% tariff on electric vehicles, 50% on solar cells, and 25% on steel, aluminium, electric vehicle batteries and critical minerals. Additionally, the US announced an increase of 50% in tariffs on Chinese semiconductors, to start later (Office of the United States Trade Representative, 13.09.2024).

Despite increasing tensions in the Middle East, oil prices weakened during the quarter, driven by concerns over a flailing Chinese economy and the prospect of OPEC+ increasing supplies. Industrial metals nickel, aluminium and copper all ended the quarter higher on the back of tighter supply and China stimulus announcements. And despite a cut in global lithium supply by one of the material's top producers, prices for lithium battery ingredients continue to be weak.

#### **Comments on transactions**

During the quarter, the fund initiated a new position in Chinese equipment manufacturer Hauming Power Equipment. Huaming is a leading global manufacturer of tap changers, a critical element in large power transformers. The transformer market is experiencing rapid growth globally on the back of network roll-outs driven by electrification, increasing interconnection and renewable power development, leading to worldwide equipment shortages. The fund liquidated its position in Chinese electrolyte producer Guangzhou Tinci Materials, as overcapacity is still depressing prices and profits in the battery chemicals space and might continue to be under pressure for some time coming. During the quarter, the fund also established a new position in Canadian copper miner Lundin Mining, which has operations and projects in Argentina, Brazil, Chile, Portugal, Sweden and the US.
