## Investment Policy

The fund assets are invested in companies which derive at least 50% of their revenues from products and services that enable, support, and promote the transition from fossil fuels to cleaner energy. Target companies operate across the entire energy value chain, and are well positioned to benefit from long-term growth drivers such as decarbonization through electrification of energy consumption, decentralization of energy systems, and the scarcity in critical materials needed for the energy transition.

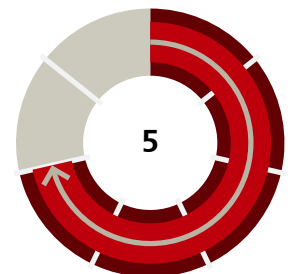

**Performance commentary**

The fund underperformed its benchmark during the quarter, driven by both stock selection and sector allocation. Top contributors to performance were US lithium producer Arcadium Lithium, which received a takeover offer from Rio Tinto during the quarter; US small modular reactor developer NuScale, which benefited from announcements on data centres looking for nuclear power; and US semi-solid state battery developer Freyr, which acquired a solar cell manufacturing plant from a Chinese producer in the US during the quarter.

Major performance detractors were Danish offshore wind power developer Oersted, which dropped after Donald Trump (who has been an open critic of the offshore wind industry) won the US presidential election; Danish wind turbine manufacturer Vestas Wind Systems, which reported another disappointing quarter, plagued by historical cost inflation in its service segment; and US renewable energy company Nextera Energy Partners, which reported lower-than-expected results leading investors to fear a lower cash flow and dividend distribution growth path.

## Market comments

Global equity markets traded slightly lower in the fourth quarter of 2024, with consumer discretionary, communication services and information technology the strongest-performing sectors and materials and healthcare among the worst. The US presidential outcome and President-elect Trump's intended tariffs dominated news headlines, and bitcoin rallied on the back of Trump's cryptocurrency support.

After having lowered rates already in November, the US Federal reserves cut its policy interest rate again in December – however with a more cautious guidance on inflation falling further. The European Central Bank also cut rates in December, as did the Swiss National Bank. The Bank of England held rate steady in December following a November cut, and the Bank of Japan refrained from raising rates during the quarter.

The last quarter of the year was a politically quite unstable one: in South Korea, Parliament voted to impeach president Yoon Suk Yeol, and voted to impeach his replacement Han Duck-soo as well just two weeks after he took office; France fell further into disarray after the no-confidence vote and resignation of Prime Minister Michel Barnier; Canada's finance minister Chrystia Freeland resigned over disagreement with Prime Minister Justin Trudeau over the Canadian budget and response to looming US tariffs; in Germany, Chancellor Olaf Scholz lost a vote of confidence after his government collapsed in November; in Syria, the regime was toppled by rebels, causing Bashar al-Assad to flee to Russia; and violence erupted in Mozambique after the governing party's win in a widely disputed election was confirmed.

Commodity prices were largely stable during the quarter, with the exception of copper and aluminium, which dropped on the back of looming US tariffs hitting China's economy. In the energy space, gas prices rose due to colder winter weather in the Northern Hemisphere, while uranium prices slightly declined during the quarter.

After what was considered a disappointing outcome of the 29th United Nations Conference of Parties (COP29) on finance for climate change initiatives in developing countries, December brought a belated COP29 pledge on energy storage and grid integration growth. Also in December, US car maker General Motors decided to halt its robotaxi development and focus on the development of advanced driver assistance system (ADAS) for personal vehicles instead. Facebook parent Meta announced it would be looking to add its own nuclear power supply to feed growing electricity demand from its data centres. Lastly, in response to US trade restrictions, China banned the export of critical materials gallium, germanium and antimony in December, rare earth elements that are used in semiconductor manufacturing and defence applications.

## Comments on transactions

During the quarter, the fund initiated a position in German electrical grid operator E.ON, which benefits from strong growth in interconnections throughout Europe. The holding in Australian lithium miner Arcadium Lithium was trimmed after the company received a takeover bid from diversified miner Rio Tinto. The fund exited its position in US-listed electric vehicle charging equipment company Wallbox on weakening fundamentals; the holding in US battery company Freyr was sold as well, after the company decided to focus its business on solar cell manufacturing. There were also some smaller rebalancing transactions during the quarter.
