#### **Investment Policy**

The fund assets are invested in companies which derive at least 50% of their revenues from products and services that enable, support, and promote the transition from fossil fuels to cleaner energy. Target companies operate across the entire energy value chain, and are well positioned to benefit from long-term growth drivers such as decarbonization through electrification of energy consumption, decentralization of energy systems, and the scarcity in critical materials needed for the energy transition.



#### Performance commentary

The fund underperformed its benchmark in January, mainly driven by stock selection within sectors. The top contributor to performance was US small modular reactor developer NuScale, followed by US rare earth metals producer MP Materials, which reported solid progress on its downstream magnet production during the month. French liquefied natural gas vessel technology company Gaztransport et Technigas also contributed positively on the back of solid order intake. Australian lithium producer Liontown Resources saw a strong contribution as the company reported a strong operational update. NextEra Energy partners was the worst performer during the month, as the company totk another writedown on its US offshore wind developments and Trump's hostility towards offshore wind. After this latest in a series of writedowns and impairments, Ørsted changed its CEO at the end of the month.

#### **Market comments**

Global equity markets went up in January, with Europe outperforming the United States, as the US-heavy Information Technology sector was the worstperforming sector. Big Tech stock saw considerable volatility at the end of the month, driven by the late-January release of China's DeepSeek Artificial Intelligence platform, which had been trained on older-generation US chips, consuming less energy but delivering strong performance on tasks. Amid fires wreaking havoc in the greater Los Angeles area, Donald J. Trump was inaugurated for his second term as President of the United States and rushed out of the gates with a series of executive orders, including US exiting the Paris Agreement, while also threatening import tariffs on Mexican and Canadian goods. President Trudeau announced his resignation following a cabinet disagreement over how to handle escalating trade tensions. And while China reported a record trade surplus, its Manufacturing Purchasing Managers' Index still presents a gloomy outlook for the domestic economy. With the eurozone and its largest economy, Germany, showing a slowdown in economic growth, the European Central Banks lowered rates in January. The Federal Reserve stayed its course and left interest rates unchanged, citing still an elevated level of inflation. The bank of Japan, on the other hand, raised rates as inflation strengthened. Oil prices rose briefly in January as new US sanctions on Russian exports were initiated, but tapered off towards the end of the month as the ceasefire between Israel and Hamas became effective in the Middle East. Uranium prices came under some pressure as the advent of DeepSeek triggered concerns about future power consumption of data centres, shortly after the US Department of Energy had published a report painting a strong stance for electricity demand growth in the wake of data centres and artificial intelligence power consumption.

#### **Comments on transactions**

During the month, the fund further increased its position in the German electrical grid operator E.ON, which benefits from strong growth in interconnections throughout Europe. The position was funded mainly by trimming some of the positions in outperformers such as US rare earth metals producer MP Materials, Australian lithium miner Liontown Resources, and Italian and Spanish electricity network operators Terna and Redeia. Lastly, the fund exited its position in US battery management software developer Stem, as fundamentals for the company have substantially deteriorated, in our view.
