The fund seeks to provide exposure to a diversified set of alternative strategies in a UCITS format with daily liquidity. It invests globally in multiple asset classes and currencies seeking to harvest diverse Risk Premia. Alternative investment strategies are implemented mainly via derivatives utilizing leverage and taking both long and short positions.

Potential Risks

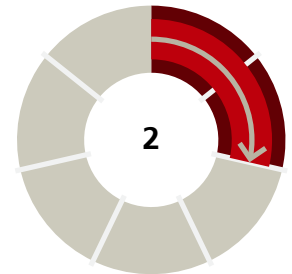
- **Credit risk:** Issuers of assets held by the Fund may not pay income or repay capital when due. The Fund's investments have considerable credit risk.

- **Event risk:** In the case a trigger event occurs contingent capital is converted into equity or written down and thus may lose substantially in value.

- **Political and Legal risks:** Investments are exposed to changes of rules and standards applied by a specific country.
