- The real estate stocks are also listed and invest almost exclusively in office buildings and retail space in Switzerland.

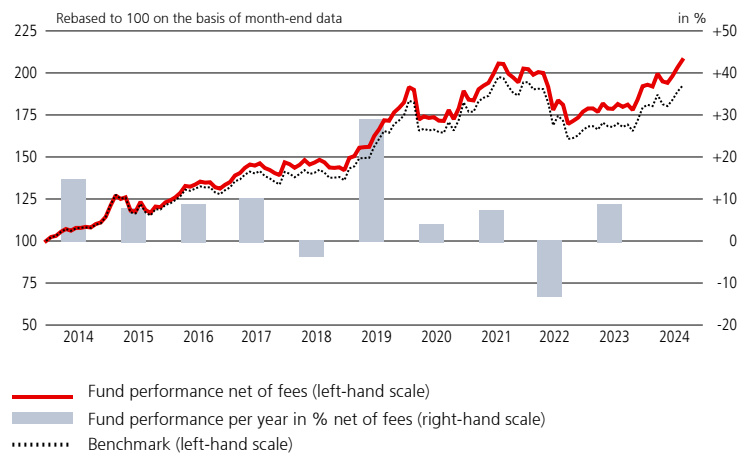
