- Important assessment criteria include not only the company's valuation but also the economic environment, the company's market positioning and the quality of the management.

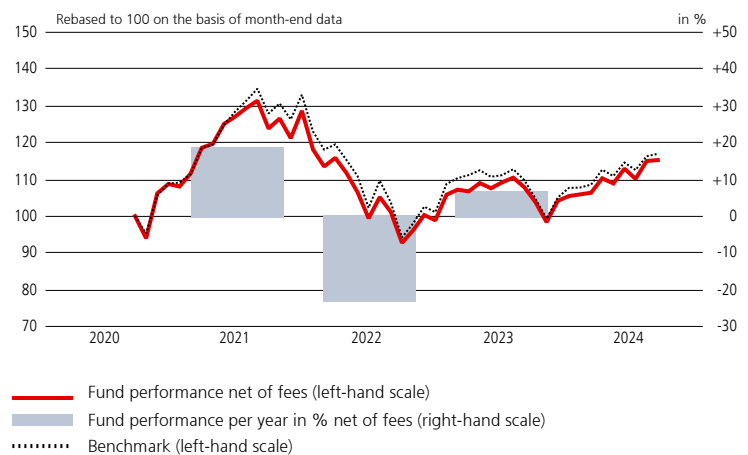
