

#### **Investment Policy**

Swissac invests primarily in shares of companies that are domiciled in Switzerland. Stock selection is based on qualitative and quantitative analyses. The portfolio manager also incorporates the sustainability approaches Stewardship & Exclusion in the investment decisions.

Due to the application of only the sustainability approaches "exclusions" and "stewardship" (Engagement and exercise of voting rights), the subfund is not sustainable and is not managed sustainably. Investing involves risk including the risk of loss of capital. Past performance does not predict future returns. 

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Maximum drawdown	Represents the worst possible result (in percentage terms) that occurred during the period being analyzed.
