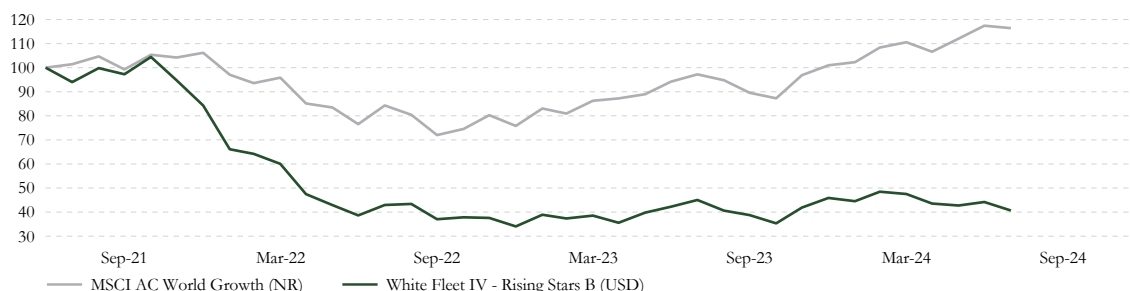

POTENTIAL RISKS
