#### **Investment Policy**


The fund invests primarily in corporate bonds, and to a limited degree in U.S. dollar-denominated bonds issued by sovereign borrowers in developing nations. In general, the Fund's investments must have an investment grade rating of BBB-/Baa3. Additionally, the fund also has the ability to invest in companies with a split rating. The fund predominately invests in USD denominated bonds and any non-USD based investment is fully hedged back into USD. The fund aims to deliver a return over the entire economic cycle that is higher than what could be achieved with bonds issued by borrowers in industrialized nations. The large investment universe offers interesting investment opportunities and allows for a broad diversification. The fund is actively managed in terms of its investment approach.



# Performance review

Under these conditions, the Emerging Market Investment Grade Fund generated a positive return on both an absolute and relative basis. In terms of relative performance, our duration and yield-curve positioning made a slightly negative contribution (-3bp). Sector allocation made a negative relative contribution (-2bp), while security selection contributed positively (+15bp). From an active excess contribution point of view, our main positive contributors were the overweight in sovereign (+16bp) and oil and gas (+6bp), as well as underweight in financials (+11bps). Security selection contributed positively to relative performance.

#### **Market Review**

In August, the performance of Emerging Market investment-grade corporate bonds was positive with positive contributions from tighter credit spreads, lower US Treasury yields and carry. US 2-year Treasury yields tightened by 34 basis points (bp) while yields on 10-year and 30-year Treasury bonds decreased by 13bp and 11bp, respectively. The US Treasury curve remains inverted with the yield differential between 2- and 10-year US Treasury notes ending the month at – 2bp. This led to a re-pricing of expected interest rate cuts and the meaningful downward move in yields across the US Treasury curve. On the credit side, EM investment-grade credit spreads tightened by 7bp with a slightly larger tightening in the BBB (8bp) compared to the A space (5bp). Of the three main EM investment-grade regions, credit spreads tightened the most in the Middle East (13bp), followed by Latin America (10bp), while Asia lagged, having tightened by 1bp.

# Glossary

Clossary	
Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Bottom-up	An investment approach that focuses on the analysis of individual stocks and de-emphasizes the macroeconomic environment.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO2-equivalent by million \$ sales. Intensities are broken down by JPM CEMBI sector and are security weighted.
ESG aware	This product undertakes investments that explicitly assess and integrate the sustainability characteristics of companies in the investment process.
ESG benchmark	A ticked 'ESG benchmark' box reflects that the ESG section in this document compares the ESG performance of the portfolio with an ESG index.
