#### **Investment Policy**


The fund invests primarily in corporate bonds, and to a limited extent in U.S. dollar-denominated bonds issued by sovereign borrowers in developing nations. The fund aims to deliver a return that over the entire economic cycle is higher than what could be obtained from bonds issued by borrowers in industrialized nations. The large investment universe encompassing many different countries with highly diverse risk profiles offers interesting investment opportunities and allows for a broad diversification. While countries are evaluated using a top-down approach, individual investments are evaluated using a bottom-up analysis. The fund is actively managed in terms of its investment approach. This share class provides a hedge against currency risk versus the reference currency (USD).

# **Performance review**

Under these conditions, the fund produced a positive return on both an absolute and relative basis. The main positive drivers of relative performance were our security selection within Asia, as well as sector allocation within Europe, while security selection within Europe had a negative impact on relative performance. Duration and yield-curve positioning made a marginally positive contribution given that tighter yields were somewhat offset by steepening of the curve. From a sector perspective, our overweight in sovereigns and real estate had the biggest positive relative performance impact, while underweight in utilities, consumer and security selection within oil & gas sectors had a negative impact. From a rating perspective, our overweight of high yield-rated versus investment graderated issuers had a positive impact on the relative performance, while security selection within both the investment grade and high yield buckets contributed positively during the month of September.

#### **Market Review**

In September, the performance of Emerging Market corporate bonds was positive driven by lower US Treasury yields as well as tighter credit spreads since the 50bp (basis points) rate cut by FOMC provided a tailwind for all risk assets especially EM, given the expectation of improving flows into the asset class. As a result, 2-year Treasury yields tightened by 28 basis points (bp) while yields on 10-year and 30-year Treasury bonds declined by 12bp and 8bp, respectively. The US Treasury curve disinverted with the yield differential between 2- and 10-year US Treasury notes ending the month at 14bp, having steepened by 16bp over the month. On the credit side, Emerging Market corporate bond credit spreads rallied, with spreads of investment grade-rated issuers tightening by 2bp while high-yield spreads tightened by 9bp. On a total return basis, while all regions delivered solid performance, Europe was the best-performing region followed by Africa, while Asia and Middle East returns came slightly lower.

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
