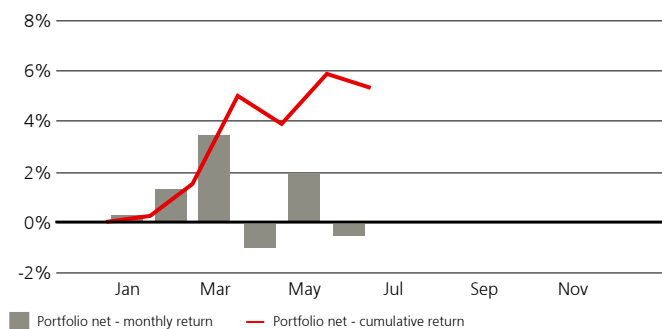

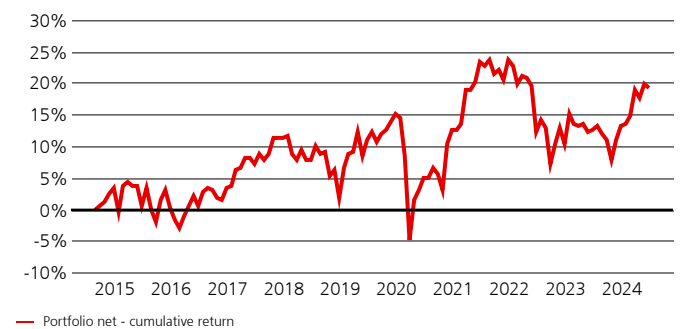
Performance overview - monthly & cumulative

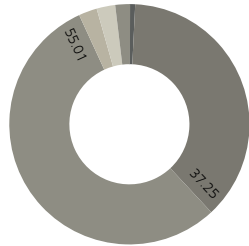

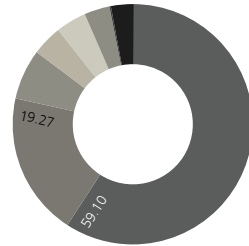
By asset class in % of total economic exposure

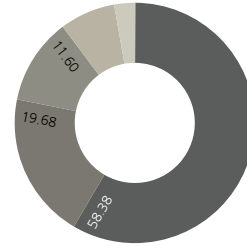
By instrument currency in % of total economic exposure (after currency hedging)

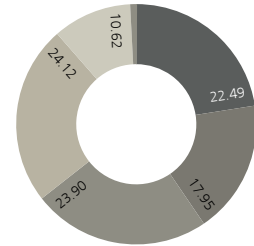
By type in % of bond economic exposure

Performance commentary

While the US stock market was further driven by the artificial intelligence rally, Europe faced some turmoil caused by Macron's announcement of a snap election, in which the right and left fringe aim to unseat Macron's centrist alliance. The global yield environment reflects the rate expectations and levels came down considerably during the month, while credit spreads changed direction on their two-year decline, albeit still at historically low levels. The USD strengthened again, climbing close to its highest level this year.

Market comments

The last half year – particularly the last month – has proven eventful. In the last week of June, chipmaker NVIDIA briefly overtook Microsoft for the title of the world's largest publicly listed company – though its shares pulled back toward the end of the week. Rate-cutting is also in full swing. Switzerland, which kicked off the easing cycle in March, surprised markets again with its second rate cut on June 20. Macro data in the US confirms decelerating economic activity and paves the way for long-awaited Fed cuts. The current data on private consumption, housing purchases, and industrial orders all point to a cooling in domestic demand. The upcoming elections in many countries, such as France, the UK, and of course the US, have already introduced some volatility into the markets and will continue to elicit some drama. The US presidential debate on June 27 and subsequent polls showed there is still no clear favorite either in the White House or in the Capitol.

Comments on positioning

The second half of 2024 is poised to be a period of transition and volatility. Investors must remain vigilant and adaptable, leveraging both strategic and tactical approaches to navigate the evolving landscape. In our asset allocation, we keep a positive view on fixed income and stay focused on high-grade/investment-grade bonds. We expect bond yields to drop as the market shifts focus from the timing of the first Fed rate cut to considering how far rates might fall. In equities, we reiterate our neutral stance in the overall allocation, keeping the UK as the most preferred region.

Comments on transactions

No major transactions. We wrote several calls and puts in order to profit from option premiums. In addition, we reallocated some of the dividend stocks.

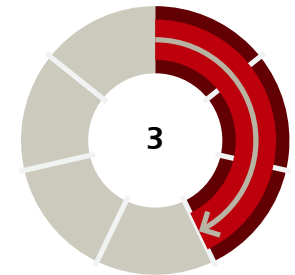

Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
