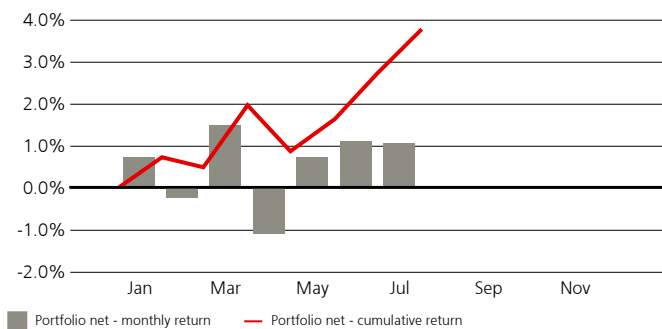
Investment Policy

The aim is to generate capital gains and asset growth on the basis of a conservative risk profile in Swiss francs. The active management is based on the tactical decisions of our investment committees and invests exclusively in a universe of traditional asset classes. An equity component of no more than 25% and clearly defined risk parameters are intended to generate a return that is in line with financial market cycles. The fund comprises mainly individual investments and the majority of the securities are from Swiss issuers. The investments are usually hedged 100% in Swiss francs. The fund observes the investment regulations in accordance with article 7 VBVV para. 1 (Ordinance on asset management under a guardianship or legal custodian).

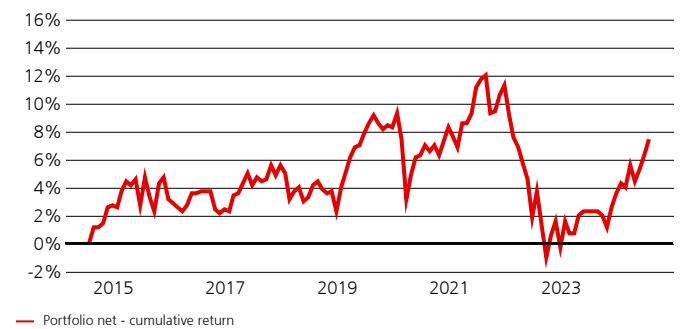
Performance overview - monthly & cumulative

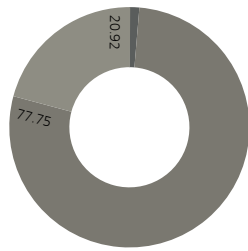

Asset breakdown

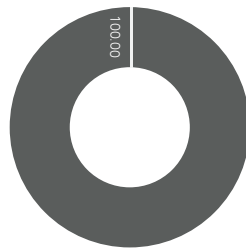
By asset class in % of total economic exposure

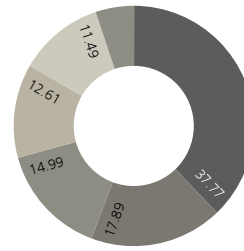
By instrument currency in % of total economic exposure (after currency hedging)

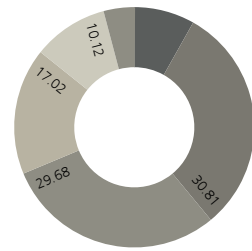
By type in % of bond economic exposure

Performance commentary

Global stocks gained ground in July, recovering from a period of weakness as confidence in the outlook for artificial intelligence bounced back. Monetary policy was eased somewhat faster than expected. Despite renewed interest rate volatility, much new issuance and recent political events in Europe, credit spreads have remained in a comparably tight range.

Market comments

Swiss GDP grew 0.8% in 2023, and we expect it to grow at a still-below-average pace of 1.3% in 2024. A gloomy economic outlook for the eurozone is weighing on industrial sentiment. External demand improved recently, but our export barometer is still in negative territory, pointing to below-trend growth in the months ahead. Swiss domestic demand looks more solid on the back of robust employment growth and declining inflation.

Comments on positioning

We remain neutral on equities and keep overall equity allocation at strategic weights. We continue to see opportunities in the bond market and lock in current yields while investing surplus liquidity. We favour broad diversification with a careful selection of securities and a tendency towards higher quality.

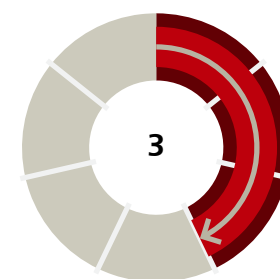

Glossary

Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
