#### Investment Policy


The aim is to generate capital gains and asset growth on the basis of a conservative risk profile in Swiss francs. The active management is based on the tactical decisions of our investment committees and invests exclusively in a universe of traditional asset classes. An equity component of no more than 25% and clearly defined risk parameters are intended to generate a return that is in line with financial market cycles. The fund comprises mainly individual investments and the majority of the securities are from Swiss issuers. The investments are usually hedged 100% in Swiss francs. The fund observes the investment regulations in accordance with article 7 VBVV para. 1 (Ordinance on asset management under a guardianship or legal custodian).

Investing involves risk including the risk of loss of capital. Past performance does not predict future returns. Neither simulated nor historical performance is a reliable indicator for current or future performance.



#### **Performance commentary**

Swiss equities largely moved sideways, with a small-scale sell-off over the last two days. This was caused by a lacklustre result from Apple which sparked concerns about the future of the tech-led rally. The 10-year Swiss government bond yield spiked in the beginning of the month over 0.5% but has corrected since. Credit spreads have generally narrowed and are hovering around zero, albeit with some volatility.

#### Market comments

This year's deliberations whether the US economy is headed for a hard or a soft landing while unwinding a historic rate hike are gravitating towards a "no landing" scenario with data pointing to receding inflation but growth remaining slightly above trend. The Fed's monetary policy is still deemed restrictive, opening opportunities for further cuts, albeit at a slower pace than expected earlier this year. The imminent presidential election might introduce some volatility to markets due to controversies around the result, however, it will most likely be of short-term nature. Meanwhile, China is still confronted with structural economic challenges stemming from a combination of an ageing population, high debt and a high degree of reliance on investment to drive growth. It faces a severe risk of "japanification" with a lost decade of slow growth and deflation. The recent policy response, to induce a major stimulus, is aimed at countering exactly this scenario. If this is sufficient to effect a turnaround remains to be seen.

#### **Comments on positioning**

We stay overweight in equities since the global environment still looks benign, which will in turn be positive for Swiss equities. Within fixed income, we retain our neutral view following strong capital gains in recent months. Going forward we see yield as more of a driver of returns rather than capital gains – warranting our neutral recommendation on high grade.

# Glossary

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself
Annualized risk	Annualized risk is a statistic, which is used to measure the risk of a fund by describing the range of returns, which were achieved in the observation period are most likely to be achieved. Greater volatility implies greater risk.
Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Carbon emission intensity	The weighted average emissions intensity, which is provided by MSCI ESG, divides the Scopes 1 & 2 emissions in tons of CO2-equivalent by million \$ sales. Intensities are broken down by GICS sector and are security weighted.
