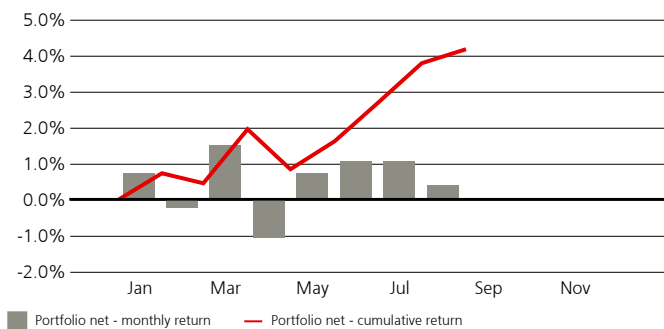
## Investment Policy

The aim is to generate capital gains and asset growth on the basis of a conservative risk profile in Swiss francs. The active management is based on the tactical decisions of our investment committees and invests exclusively in a universe of traditional asset classes. An equity component of no more than 25% and clearly defined risk parameters are intended to generate a return that is in line with financial market cycles. The fund comprises mainly individual investments and the majority of the securities are from Swiss issuers. The investments are usually hedged 100% in Swiss francs. The fund observes the investment regulations in accordance with article 7 VBVV para. 1 (Ordinance on asset management under a guardianship or legal custodian).

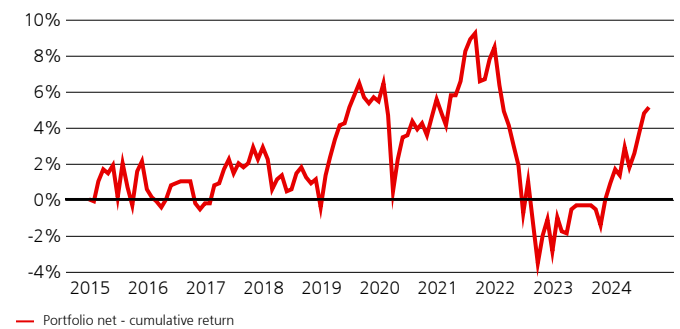
## Performance overview - monthly & cumulative

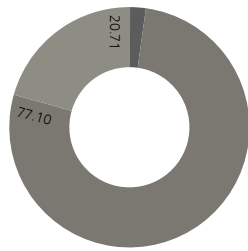

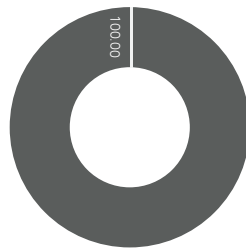
By asset class in % of total economic exposure

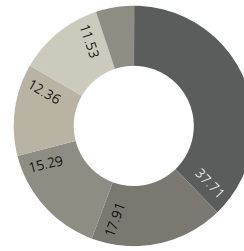
By instrument currency in % of total economic exposure (after currency hedging)

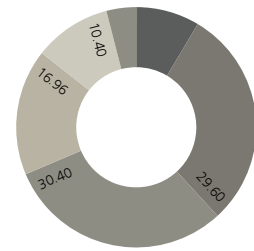
By type in % of bond economic exposure

**Performance commentary**

Swiss equity markets ended the month positive. CHF bonds were slightly positive, led by high-grade foreign bonds with maturities of 1 to 10 years.

**Market comments**

The drop in the financial markets from the end of July to early August was fortunately followed by an upward counter-movement. In recent days, this has transformed into a gradual rise. The intermezzo of market volatility in early August has given us a taste of what this autumn could bring in terms of economic and geopolitical developments.

**Comments on positioning**

While we see the overall environment as constructive for equities, uncertainty about the economic and political outlook is likely to persist. We remain neutral on equities overall. Our base case is for a soft landing for the US economy, with growth bottoming below the trend rate and inflation moderating further. Rates remain on an elevated level if viewed historically, and we believe there is still value in fixed income. We consequently keep investment grade on most preferred.

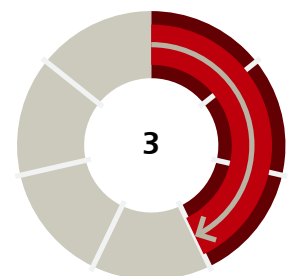

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
